**RATEPAYER REPRESENTATIVES' OBJECTIONS TO SUPPLEMENTAL REBUTTAL TESTIMONY OF MIKE NELSON AND MOTION TO STRIKE**

TO THE HONORABLE ADMINISTRATIVE LAW JUDGES:

THE REPRESENTATIVES OF THE RATEPAYERS OF WINDERMERE OAKS  
WATER SUPPLY CORPORATION (“Ratepayers”) file this their Objections to the  
Supplemental Rebuttal Testimony of Mike Nelson and Motion to Strike and would show as  
follows.

## Timely Filing

Pursuant to SOAH Order No. 23, objections to Supplemental Rebuttal Testimony must be filed by March 3, 2023. Accordingly, Ratepayers' Objections and Motion to Strike is timely filed.

## Summary of Bases for Motion to Strike

According to Mr. Nelson, the purpose for his Supplemental Rebuttal Testimony (“Nelson Testimony”) is to demonstrate that Windermere will not have enough revenue to pay all of its bills and will default on its loan covenants if required to implement Staff’s recommended rates and/or to refund overcharges to its customers. Ratepayers move to strike the Supplemental Rebuttal Testimony of Mike Nelson (“Nelson Testimony”) on the grounds that (i) it is not relevant to the determination of any issue in the Preliminary Order, (ii) any

slight probative value is outweighed by a danger of unfair prejudice, confusing the issues undue delay, (iii) to the extent intended as opinion testimony, it does not meet the standards for admissibility under Rules 701 and 702 or the common law, and (iv) Windermere failed to timely comply with its discovery obligations concerning the matters addressed in the Nelson Testimony.

### Applicable Substantive Law

Regulated utilities in Texas are under a legal duty to charge just and reasonable rates and to ensure that they are not unduly discriminatory. *Black v. City of Killeen*, 78 S.W.3d 686, 699 (Tex. App. – Austin 2002, pet. denied). To prove its rates are just and reasonable, the utility must show that the rates provide revenue equal to its cost of service and recover costs from ratepayers equitably.<sup>1</sup> The utility must show its rates recover only its reasonable and necessary expenses to provide service and collect only expenses actually realized or which can be anticipated with reasonable certainty.<sup>2</sup> These requirements apply regardless of whether the utility uses the cash-basis or utility-basis method to set rates.<sup>3</sup>

Before a cash-basis utility can set (or defend) new rates, it must first determine a reasonable revenue requirement.<sup>4</sup> Cash basis accounting determines basic revenue requirements by adding up operation and maintenance expense, debt service requirements, and capital expenditures that are not debt financed, if all such costs are related to its actual

cost of providing service.<sup>5</sup> It may also include additional debt-service coverage if it is appropriate for the utility to maintain a certain debt-service-coverage ratio.<sup>6</sup> Debt service may be included in the cost of service for purposes of ratemaking so long as the debt is from “reasonably and prudently incurred loans.”<sup>7</sup> A rate cannot be deemed just and reasonable unless the utility was prudent in incurring the operating expenses it seeks to pass through to consumers. *Gulf States Utilities Co. v. Pub. Util. Comm'n of Texas*, 841 S.W.2d 459, 466 (Tex. App. – Austin 1992, writ denied).

Budget data can be used to establish cost of service for rate-setting purposes. However, the utility must prove the data is a reasonable approximation of the actual costs of providing services and that the budgeted costs are reasonable and necessary to provide service to customers.<sup>8</sup> To meet this burden of proof, the utility must provide specific evidence of cost increases that it will encounter in the future for specific items.<sup>9</sup> Speculation that the future will look like the past and inflation will occur is not evidence of a known and measurable change.<sup>10</sup>

When the Commission sets rates under 13.043, it must use a “*methodology* that preserves the financial integrity of the retail public utility.” Tex. Water Code § 13.043(j) (emphasis added). A methodology is not something that is unique to an individual case.

Rather, it is a “body of methods, rules and postulates employed by a discipline; a particular procedure or set of procedures” that are applied evenly to all cases.<sup>11</sup>

In the exercise of its appellate jurisdiction, the Commission is not required to fix a utility’s overall revenues at a level that will preserve the financial integrity of a utility.<sup>12</sup> Considerations of financial integrity cannot be treated as a trump card that overrides the utility’s obligation to comply with the standard requirements for proving its water and sewer rates.<sup>13</sup> A CCN is not a guarantee that “every inefficient or imprudent expenditure will be passed on to the consuming public.”<sup>14</sup>

Consistent with these well-established principles, the Preliminary Order identifies, *inter alia*, the following issues to be addressed in this proceeding:

- Do the retail water and sewer rates being charged to petitioners by Windermere fulfill the requirements of TWC §13.043(j)?<sup>15</sup>
- Considering only the information available to Windermere at the time of its decision, what are the just and reasonable rates for Windermere’s customers that are sufficient, equitable, and consistent in application to each customer class and that are not unreasonably preferential, prejudicial, or discriminatory?<sup>16</sup>
- What is the revenue requirement that would give Windermere sufficient funds to provide adequate retail water and sewer service to petitioners?<sup>17</sup>
- If the Commission establishes rates different from the rates set by Windermere, should the Commission order refunds or allow surcharges to recover lost revenues?<sup>18</sup>

Noticeably absent from the list of issues to be addressed is any inquiry as to what rate would give Windermere sufficient funds to pay all its bills.

### Pertinent Procedural History

Since before the appealed rates were approved, Windermere has portrayed that the rates were developed by TRWA using TRWA’s “cash-needs” rate study tool. From the beginning of this proceeding, Windermere has portrayed that the appealed rates were developed by TRWA using TRWA’s “cash-needs” rate study tool and Windermere’s 2019 year end financials, which reflect costs paid but do not reflect costs incurred during 2019.

The only rate study Windermere has sponsored in this appeal is found at Attachment MN-2 (WOWSC Exhibit 7 at bates pages 024-5). That rate study is based on a systemwide revenue requirement of \$576,192, of which \$364,252 is categorized as fixed costs and \$221,940 is categorized as variable costs. The revenue requirement includes \$171,337 for “Accounting & Legal.” Throughout this proceeding, Windermere has portrayed to the tribunal and to the other parties that \$171,337 in outside legal costs is the focus of the dispute.

Ratepayers became openly skeptical about the veracity of these claims.<sup>19</sup> After all, the TRWA rate study was not based on the total cost to provide service in 2019, but on the amounts Windermere’s board chose to disburse during that year. The TRWA rate study was not based on the costs in Windermere’s approved budget for 2020, which was higher for many expense categories (not just “Legal & Accounting”) than the costs paid in 2019.<sup>20</sup> The TRWA rate study did not include any amount for anticipated needs to improve, update, construct,

and maintain the utility system. The TRWA rate study did not include any amount for debt service coverage requirements.

Perhaps even more dramatic, the TRWA rate study suggested that to recover a revenue requirement of \$576,192 Windermere's rates would need to be greater than the rates the board later approved and would require an increase in Windermere's gallonage rates. Setting aside the disputed outside legal costs, the omissions from the TRWA study combined with the ad hoc rate the board selected left Ratepayers to wonder whether the board ever paid any real attention to how the utility planned to pay both its burgeoning legal costs and its costs to provide service.

Despite Ratepayers' open skepticism and repeated inquiries, Windermere was steadfast in its position throughout the discovery process and well into the appeal hearing. PUC Staff reviewed and analyzed the 2019 cost data provided by Windermere and developed and filed testimony and rate recommendations based on the TRWA revenue requirement and its components reflected in the only rate study Windermere furnished.<sup>21</sup> Windermere did not disclose that Windermere itself had never developed a revenue requirement or that its board based the appealed rates on budgeted cost data for 2020 and not on the 2019 data for paid costs Windermere had produced. Windermere certainly never claimed the utility's total costs to be recovered through rates were greater than even its 2020 budgeted costs.

Windermere had the burden of proof on these issues and the duty to provide complete and relevant information, with or without request by PUC Staff or Ratepayers.<sup>22</sup>

Windermere has now admitted in discovery that the appealed rates were not designed by TRWA, were not designed using the “cash-needs” approach, were not designed to recover the revenue requirement of \$576,192 reflected in the TRWA rate study (or any other revenue requirement) and were not designed to recover \$171,337 (or any other specific amount) for outside legal costs.<sup>23</sup> Windermere has belatedly admitted it did not develop a revenue requirement when the board approved the appealed rates, and has not developed a revenue requirement in the interim. Without a revenue requirement, Windermere cannot prove the appealed rates were designed with an accepted methodology to recover reasonable and prudent costs of service, debt coverage and cash-funded system improvements.

Windermere also failed to comply with its duty to make complete responses to discovery. By way of illustration, Ratepayers have specifically requested that Windermere provide detailed information about its 2020 budgeted costs and, in particular, the amount of any claimed “known and measurable changes.”<sup>24</sup> Windermere has refused to provide the requested information and has forced Ratepayers to move to compel.<sup>25</sup> Ratepayers have specifically requested that Windermere provide a complete copy of its QuickBooks data<sup>26</sup> for 2020 forward; this data includes (or should include, if the platform is used properly) detailed information about Windermere’s costs and payments, including source documents (i.e., invoices and receipts) and original payment records. Windermere represented (both in its

response to Ratepayers' 8-24 and verbally to counsel) that it had provided the requested copy. It did not; rather, Windermere provided only a PDF of its general ledger spreadsheet.

#### The Nelson Testimony is Not Relevant/Any Slight Relevance is Outweighed

As discussed above, the Preliminary Order does not identify as an issue to be addressed whether Windermere will have sufficient revenue "to pay all its bills." This is because Windermere is not entitled to recover from its ratepayers sufficient revenue "to pay all its bills." Under the Water Code, Windermere's rates may not recover "all its bills." Windermere's rates may recover no more than its reasonable and necessary expenses, debt service requirements, and capital expenditures that are not debt financed, provided such costs are actually realized or can be anticipated with reasonable certainty and are related to Windermere's actual cost of providing service.

In the absence of a revenue requirement that includes "all its bills," however, whether Windermere will have sufficient revenue "to pay all its bills" with one set of rates or another is not relevant to any issue set forth in the Preliminary Order. The Nelson Testimony appears to assume, but certainly does not attempt to prove, that "all its bills" are recoverable from its ratepayers.

Aside from general references to Windermere's outside legal costs and "cash capital outlays," the Nelson Testimony does not identify or provide any detail as to what is included within "all its bills."<sup>27</sup> As to at least two of the "capital projects," both funded with assistance from the LCRA, Windermere itself has acknowledged the costs far exceed any tangible benefit to the ratepayers.<sup>28</sup>

The legal expenses within “all its bills,” which include over \$800,000 that has been paid and an even larger balance owed for outside legal services rendered during 2019 through the present, are almost certainly unrecoverable as a matter of law. It is acknowledged the legal expenses are not costs of providing water and sewer service to Windermere’s ratepayers.<sup>29</sup> Further, Windermere has admitted in discovery that its board had no idea when it approved the appealed rates whether the 2020 budgeted cost for “Legal/Appraisal” was a reasonable approximation of its actual cost for legal services for 2020.

The debt “reserves” and DSCR requirements were created pursuant to loan documents executed long after the board approved the appealed rates. The TRWA rate study did not include cost amounts for these items. The Nelson Testimony does not include any loan commitments or other documentation or make any other effort to prove that these obligations were known to the board or could have been included within the appealed rates. Similarly, the Nelson Testimony does not include or describe his calculations or the data on which he relied in making the calculations, therefore it cannot be determined whether his figures are a reasonable approximation of the actual cost.

#### Failure to Make a Complete Response to Discovery

As discussed above, promptly upon learning it was necessary, Ratepayers served Windermere with extensive discovery concerning “all its bills.” By way of example, Ratepayers’ 8-2 specifically requested that Windermere state the revenue requirement (in dollars and cents) Windermere contends would enable it to pay its costs to provide service, to maintain loan covenant reserves and to perform its DSCR and other loan covenants, and to

describe in detail how the revenue requirement was calculated. In response, Windermere provided four dollar amounts that it described as “the absolute minimum to be recovered to remain in compliance.” The lowest of these figures exceeds Windermere’s 2020 budgeted costs by over \$40,000.00.<sup>30</sup>

Windermere did not provide any detail as to costs based on which these amounts were calculated. At the same time, Windermere stated that none of these amounts is a revenue requirement, and none would be appropriate to use for setting rates.

Accordingly, it remains unclear whether any of these figures encompass “all its bills.”

Similarly, Ratepayers Amended 6-9 and Ratepayers’ 8-24 requested detailed information concerning Windermere’s 2020 costs and revenues, both budgeted and actual. As the ALJs may recall, Windermere’s financial reports reflect only the amounts Windermere’s board has chosen to pay during the reporting period. They do not accurately reflect the utility’s financial obligations paid or incurred for that period. As discussed above, Windermere has yet to provide the requested information.

Pursuant to Rule 193.6, Windermere’s failure to make complete and timely responses to Ratepayers’ discovery requests on the exact subject matter of the Nelson Testimony triggers mandatory exclusion of such Testimony.

#### Inadmissible Opinion Testimony

The Nelson Testimony does not meet the requirements for admissibility as opinion testimony.

Mr. Nelson does not portray himself as any sort of expert in matters of rate-setting or public utility accounting, and it does not appear he has any such expertise. He is not qualified

to opine as to the establishment of a revenue requirement, the recoverability of expenses, the “just and reasonable” standards or any similar matter pertinent to the issues identified in the Preliminary Order.

Mr. Nelson does not portray himself as any sort of expert in matters of contract interpretation or matters of banking or finance, and it does not appear that he has any such expertise. He is not qualified to opine as to matters such as the proper calculation of the DSCR requirement and other covenants of the CoBank loan documents. Further, the Nelson Testimony purporting to predict the future if CoBank were to discover that Windermere was in default on any of the loan covenants<sup>31</sup> is rank speculation.

Mr. Nelson does not portray himself as any sort of expert in matters of corporate structure, and it does not appear that he has any such expertise. He is not qualified to opine as to matters such as the obligations and responsibilities of shareholders of IOU utilities or even as to the obligations and responsibilities of members of a nonprofit water supply corporation.<sup>32</sup>

Mr. Nelson’s proffered opinions concerning the possible impact should Windermere stop making payments to the law firms are, by his own admission, speculation. Mr. Nelson’s testimony is also unreliable because no “legal payment agreements” exist. Windermere has admitted there is no record of any board approval of the alleged “payment agreements” at a properly noticed and conducted open meeting.<sup>33</sup>

As discussed fully above, the Nelson Testimony assumes, but does not attempt to prove, that “all its bills” are recoverable from Windermere’s ratepayers. That assumption is not accurate, either legally or factually, and Windermere has the burden of proof on the issue.

WHEREORE, premises considered, Ratepayers respectfully request that the foregoing Objections be sustained and that the Nelson Testimony be stricken, in whole or in part, and that Ratepayers be awarded such other and further relief, at law or in equity, to which they may show themselves justly entitled.

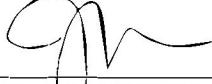

**WOWSC'S RESPONSE TO STAFF'S EIGHTH RFI**

**STAFF 8-5:** For the test year, for each amount listed above, please state whether the amount for a) tap fees; b) stand-by fees; c) equity buy-in fees; and d) membership fees was deducted from the revenue requirement used to set the appealed rates.

**RESPONSE:** Based on previous years' experience, WOWSC estimated that roughly \$73,750 from the fees above would support the 2020 budget and that amount was included in the 2020 Income section of the budget. The 2020 budget shows a projected \$174,515 shortfall. The rates were ultimately raised to address that projected shortfall. Thus, the amount for the fees above were incorporated into the budget and rates were raised to address the projected shortfall.

**RESPONSE:** WOWSC's did not design its rates to recover \$171,337. See Response to Staff 8-8.

However, WOWSC did utilize money saving options, standby fees, and equity buy-in fees that totaled nearly \$35,000. Money saving options included conservation processes that offset initial expenses with a LCRA partial matching grant. See Attachment Staff 8-9 and LCRA senior account manager Gabe Smith comments at [WOWSC Informational Meeting #1 October 17 2022 - YouTube, 38:00-43:00.](#)

In sum, WOWSC recovered the remaining amount with cost-cutting, the grant, standby and equity buy-in fees, and volumetric income.

Reference Joe Gimenez Supplemental Rebuttal Testimony, p. 4, line 13 – p. 5, line 2. Please state (in dollars and cents) the revenue requirement Windermere contends is required for it to meet loan covenant reserves, to pay its costs to provide water and wastewater services and to meet its DSCR under the CoBank Credit Agreement in each of 2020, 2021, 2022 and 2023, and describe in detail how each revenue requirement was calculated.

**RESPONSE:**

See Attachment Ratepayers 8-2 for the information requested. However, it is important to note that the amounts shown in the attachment do not represent a revenue requirement. Revenue requirement is a term of art primarily associated with rate studies. WOWSC develops a budget each year, but it does not conduct a rate study each year. Thus, the information provided in response to Ratepayers 8-2 is indicative of what WOWSC contends should be (or should have been) recovered from ratepayers in each year indicated to meet loan covenant reserves, to pay its cash operating costs to provide water and wastewater services, and to meet its DSCR under the CoBank Credit Agreement.

Importantly, this amount represents the absolute minimum to be recovered to remain in compliance. Industry practice would suggest the utility should target recovering more than this bare minimum amount to ensure unexpected increases in costs or decreases in revenues do not result in non-compliance. The amounts shown do not reflect possible capital funding needs either, which should be considered in a rate study. In short, the amounts provided are not revenue requirements and would not be appropriate for setting rates.
