

### COMMISSION STAFF'S REQUEST FOR EXTENSION

On April 27, 2020, the City of Richland (Richland) filed an application to obtain a water certificate of convenience and necessity (CCN) and for dual certification with Corbet Water Supply Corporation (Corbet WSC), CCN No. 12278, and Pleasant Grove Water Supply Corporation (Pleasant Grove WSC), CCN No. 10756, in Navarro County, Texas.

On December 17, 2021, the administrative law judge filed Order No. 7, which established a deadline of February 11, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file a final recommendation on the application. Therefore, this pleading is timely filed.

#### I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On January 22, 2021, Richland filed its consent to the map and certificate provided by Staff. While Corbet WSC filed its consent on January 29, 2021, the consent form does not indicate whether Corbet WSC concurs with the map provided by Staff. Finally, as of the date of this filing, Pleasant Grove WSC has not yet filed its consent form. Staff therefore requests that the deadline for its final recommendation be extended to March 4, 2021 to allow time for Corbet WSC and Pleasant Grove WSC to file completed consent forms and for Staff to review those forms.

#### II. CONCLUSION

For the reasons discussed above, Staff respectfully requests that the deadline for its final recommendation be extended to March 4, 2021.
