# COMMISSION STAFF'S RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS AND PROPOSED NOTICE AND AGREED PROCEDURAL SCHEDULE

**COMES NOW** the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Recommendation on Administrative Completeness and Proposed Notice and Agreed Procedural Schedule. Staff recommends that the application be found administratively complete. In support, Staff shows the following:

## I. BACKGROUND

On May 4, 2020, West Harrison Water Supply Corporation (West Harrison) filed an application to amend its water Certificate of Convenience and Necessity No. 12728 in Harrison County, Texas under Texas Water Code §§ 13.242 to 13.250 and 16 Texas Administrative Code §§ 24.225 to 24.237. On May 13, 2020, West Harrison filed supplemental information, and on July 1, 2020, West Harrison amended the application to increase the acreage of the requested area from approximately 437 acres to approximately 447 acres

On July 10, 2020, the Administrative Law Judge (ALJ) issued Order No. 3, which set a deadline of August 7, 2020, for Staff to file comments on the administrative completeness of the revised application and proposed notice and for West Harrison and Staff to file a recommendation on how to proceed with the application and propose a procedural schedule. This pleading therefore is timely filed.

## II. RECOMMENDATION ON ADMINISTRATIVE COMPLETENESS

Staff has reviewed the amended application and supplemental information filed by West Harrison and, as detailed in the attached memorandum of Jolie Mathis of the Commission's Infrastructure Division, recommends that it be found administratively complete from a technical perspective. Staff further recommends, as detailed in the attached memorandum of Fred

Bednarski of the Commission's Rate Regulation Division, that the application be deemed sufficient from a financial perspective.

#### III. RECOMMENDATION ON NOTICE

At this time, Staff recommends that West Harrison proceed with providing public notice to all persons, political subdivisions, and other entities listed in the attached memorandum using the notice provided by Ms. Mathis. Along with each individual notice, Staff recommends that West Harrison provide an accurate map delineating the requested service area. Staff also recommends that West Harrison publish notice once each week for two consecutive weeks in a newspaper of general circulation in Harrison County using the notice provided by Ms. Mathis.

Within 30 days of the provision of notice, Staff recommends that West Harrison file proof of notice as described in the attached memorandum and proof of newspaper publication. Finally, it is recommended that West Harrison use the attached affidavits to meet these requirements.

#### IV. AGREED PROPOSED PROCEDURAL SCHEDULE

Staff has conferred with a representative for West Harrison and is authorized to propose the following agreed procedural schedule for further processing of the docket:

On May 4, 2020, West Harrison Water Supply Corporation (Applicant) filed with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 12728 in Harrison County, Texas under Texas Water Code §§ 13.242 to 13.250 and 16 Texas Administrative Code §§ 24.225 to 24.237.

Staff from the Infrastructure Division has reviewed the information filed by the Applicant on May 4, May 13, and July 1, 2020 and recommends that the application be deemed administratively complete. Staff further recommends the Applicant be required to do the following:

- 1) Provide notice of the application by first-class mail to the following:
  - a. Cities, districts, and neighboring retail public utilities providing the same utility service whose corporate boundaries or certificated service area are located within two miles from the outer boundary of the requested area:
    - Gill WSC (CCN No. 10365)
    - Talley WSC (CCN No. 10414)
    - Little Cypress Utility District
    - Sabine River Authority
  - b. The county judge of each county that is wholly or partially included in the requested area:
    - Harrison County Judge
  - c. Each owner of a tract of land that is at least 25 acres and is wholly or partly located in the requested area. Notice must be mailed to the owner of the tract of land according to the most current tax appraisal rolls of the applicable central appraisal district at the time the application was filed.
  - d. Any affected customers, and other affected parties in the requested area.

2) Publish notice in a newspaper having general circulation in the county where the requested area is located, once each week for two consecutive weeks. Proof in the form of a publisher's affidavit must be filed within 30 days of the publication date. The affidavit must state with specificity each county in which the newspaper is of general circulation. Within 30 days of the date the

notice was mailed, Applicant must file an affidavit specifying the notice that was provided to every person and entity to whom notice was provided and the date the notice was mailed.

- 3) Provide notice and proof of notice using the attached notice and affidavit forms.
- 4) Provide a copy of map delineating the requested area with each individual notice to neighboring utilities, other affected parties, landowners and customers.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to the Applicant. The Applicant will have 20 days from the receipt of the RFI to provide a response.


