ARTICLE I.

The name of the Corporation is West Harrison Water Supply Corporation.

ARTICLE II.

The corporation is a non-profit Corporation organized under Article 1131a of the Revised Civil Statutes of Texas of 1925, as amended, supplemented by the Texas Non-Profit Corporation Act, Article 1.01 et seq., as amended, and is authorized to exercise all powers, privileges and rights conferred on a Corporation by these Acts, and all powers and rights incidental in carrying out the purposes for which the Corporation is formed, except such as are inconsistent with the express provisions of these Acts.
