**VILLAGE OF VINTON'S STATUS UPDATE**

TO THE PUBLIC UTILITY COMMISSION OF TEXAS:

COMES NOW, the Village of Vinton (the "Village"), by and through its undersigned attorneys of record, and files this Status Update regarding the above-referenced application. The Village would respectfully show as follows:

**I. BACKGROUND**

On May 5, 2020, Vinton Hills Alegre, LLC ("Vinton Hills") and the Village (collectively, the "Applicants") filed the above-referenced application for sale, transfer, or merger of facilities and certificate rights in El Paso County (the "Application"). On October 23, 2020, the Administrative Law Judge ("ALJ") issued Order No. 6 in this matter, approving the transaction proposed in the Application (the "Transaction") to proceed and be consummated. Order No. 6 also directed the Applicants to file monthly updates regarding the status of their efforts to close on the Transaction. Therefore, this Status Update is timely submitted.

**II. STATUS UPDATE**

Although, as of the date of this filing, the Applicants have not completed the Transaction, they intend and desire to do so as expeditiously as possible. In furtherance of that goal, the Village has continued its search for a qualified contractor to manage, operate, and maintain the to-be-acquired water systems upon closing of the Transaction. The Applicants intend to set a date for such closing as soon as an operator has been selected. Until then, the Applicants will

continue their efforts to timely complete the Transaction, submitting monthly status updates thereon in accordance with Order No. 6.

### **III. CONCLUSION AND PRAYER**

For the above-stated reasons, the Village respectfully submits, and requests that the ALJ accept, this Status Update, and grant all other relief to which the Village is entitled.
