

NORTHTOWN ACRES' ADDITIONAL AFFIDAVIT ADDRESSING CLOSING OF TRANSACTION AND TRANSFER OF CUSTOMER DEPOSITS

COME NOW Sheroll and Roger Richardson dba Northtown Acres Water Supply (Northtown Acres) and files this affidavit of Sheroll Richardson as proof of closing of the transaction and transfer of customer deposits. In support thereof, Northtown Acres shows the following:

I. BACKGROUND

On May 5, 2020, Sheroll Richardson, administrator of the Estate of Herb Madison (Estate) and Sheroll and Roger Richardson dba Northtown Acres Water Supply (Northtown Acres) (collectively, Applicants) filed an application for an amendment of a certificate of convenience and necessity (CCN) and a sale, transfer, or merger (STM) of facilities and certificate rights in Navarro County, Texas. The Applicants seek approval to acquire facilities and to transfer all of Northtown Acres' water CCN No. 11704 from the Estate to Northtown Acres. The area to be transferred is currently certificated to Northtown Acres and includes approximately 1,810 acres and 167 current customers. The uncertificated area being requested in this application, located within the North Petty Chapel Subdivision, includes approximately 2,042 acres and 211 current customers.

Order No. 8, issued by the Commission administrative law judge (ALJ) on October 16, 2020, approved the sale and transaction between the Estate and Northtown Acres and permitted the transaction to proceed. Order No. 8 also requires Northtown Acres to file proof that the transaction has been consummated and customer deposits, if any, have been

addressed. On November 19, 2020, Northtown Acres filed the Affidavit of Roger Richardson attesting to the closing of the transaction and the transfer of customer deposits. Pursuant to discussions with Staff, Northtown Acres is also filing, attached hereto, the Affidavit of Sheroll Richardson attesting to the closing of the transaction and the transfer of customer deposits.

II. CONCLUSION

Northtown Acres respectfully requests that the Commission issue an order consistent with Order No. 8, transferring the water facilities and CCN from the Estate to Northtown Acres.
