

Dear Ms. Dowd,

Pursuant to Tex. Water Code § 13.257(r)&(s), Sheroll and Roger Richardson d.b.a. Northtown Acres Water Supply is filing the attached amended water Certificate of Convenience and Necessity and Service Area Map.

The approved service area is split into two areas as shown on the attached Service Area Map and the boundaries of each area are described with verifiable landmarks as follows:

- The northern service area is located approximately 3 miles northwest of downtown Corsicana, Texas, and is generally bounded on the north by Chambers Creek; on the east by US IH 45; on the South by NW County Road 0001; and on the west by NW County Road 0010. The total area within the northern service area is approximately 1,810 acres.
- The eastern service area is located approximately 2 miles northeast of Corsicana, Texas, and is
  generally bounded on the north by NW County Road 0100; on the east by NE County Road 0080;
  on the south by FM 2041 aka W. Roane Road; and on the west by IH 45. The total area within
  the eastern service area is approximately 232 acres.

Please accept this letter and boundary description, along with the attached Certificate of Convenience and Necessity, and Service Area Map for filing in the real property records of Navarro County, Texas, pursuant to Tex. Water Code § 13.257(s).
