**ORDER NO. 6**

**FINDING NOTICE SUFFICIENT, REVISED MAPPING SUFFICIENT, AND  
ESTABLISHING PROCEDURAL SCHEDULE**

This Order addresses the sufficiency of the notice of the application filed on May 18, 2020 by Manville Water Supply Corporation (Manville WSC) to amend its water certificate of convenience and necessity number 11144 in Williamson County, the sufficiency of the revised mapping, and establishes a procedural schedule.

**I. Sufficiency of Notice**

On October 14, 2020, Manville WSC filed an affidavit attesting to the provision of notice to current customers, neighboring utilities, and affected parties. Manville WSC included a copy of the notice and maps sent, and a list of persons and entities that received notice. On December 29, 2020 and January 5, 2021, Manville WSC filed publisher's affidavits showing that notice was published in the *Taylor Press*, a newspaper of general circulation in Williamson County, on December 13 and 20, 2020, and that notice was published in the *Lexington Leader*, a newspaper of general circulation in Lee County, on December 17 and 24, 2020.

On January 25, 2021, Commission Staff filed a supplemental recommendation on the sufficiency of notice.

The administrative law judge (ALJ) finds the notice sufficient.

**II. Sufficiency of Revised Mapping**

On November 9, 2020, Mr. Barry B. Barker filed an opt out request. Mr. Barker supplemented the opt out request on November 12, 2020. On November 13, 2020, Manville WSC filed revised mapping reflecting the opt out request for Mr. Barker.

On January 25, 2021, Commission Staff filed a recommendation on sufficiency of mapping revisions.

The ALJ finds the revised mapping sufficient.

### **III. Procedural Schedule**

The ALJ establishes the following procedural schedule for further processing of the application:

Deadline to Intervene	January 29, 2021
Deadline for Commission Staff to provide final maps, certificates, and tariffs (if applicable), to the applicant for review and consent	March 1, 2021
Deadline for Manville WSC to file signed consent forms with the Commission	March 15, 2021
If no hearing is requested, deadline for Commission Staff to file a final recommendation on the application	March 29, 2021
If no hearing is requested, deadline for the parties to file joint proposed findings of fact, conclusions of law, and ordering paragraphs	April 12, 2021
