COMMISSION STAFF'S REQUEST FOR EXTENSION

On May 18, 2020, Manville Water Supply Corporation (Manville WSC) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11144 in Lee County. The requested service area consists of 9,322 acres and 54 customer connections. Manville WSC filed supplemental information on June 10, July 30, and August 11, 2020 and on and April 22, 2021.

On March 3, 2021, the administrative law judge filed Order No. 7, which established two different timelines depending on whether Manville WSC can demonstrate a need for service in the entire requested area. The Staff of the Public Utility Commission of Texas (Staff) contends that Manville WSC cannot demonstrate a need for service in the entire requested area. As a result, Manville WSC filed supplemental mapping, and Staff must file a supplemental recommendation on the amended application and maps by April 30, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Under 16 Texas Administrative Code § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Order No. 7 set April 12, 2021 as the deadline for Manville WSC to file supplemental mapping information; however, Manville WSC did not file the supplemental maps until April 22, 2021. Staff needs additional time to review those maps. Therefore, Staff respectfully requests an extension of time until May 21, 2021 to file its supplemental recommendation on the amended application and maps. Staff will propose a procedural schedule for continued processing of this docket alongside its recommendation.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the deadline for Staff to file its supplemental recommendation on the sufficiency of the amended application and maps and proposed procedural schedule to May 21, 2021.
