#### APPLICATION OF MANVILLE WATER SUPPLY CORPORATION TO AMEND ITS CERTIFICATE OF CONVENIENCE AND NECESSITY IN LEE AND WILLIAMSON COUNTIES

# 0861 PUBLIC UTILITY COMMISSION OF TEXAS

#### COMMISSION STAFF'S RECOMMENDATION ON SUFFICIENCY OF AMENDED MAPPING AND PROPOSED PROCEDURAL SCHEDULE

On May 18, 2020, Manville Water Supply Corporation (Manville WSC) filed an application to amend its water certificate of convenience and necessity (CCN) No. 11144 in Lee and Williamson Counties. The service area initially requested consisted of 9,204 acres and 54 customer connections. On April 22, 2021, Manville WSC filed revised mapping and digital data to reduce the size of the requested area to include only those areas with existing customers, with facilities, and the areas in between, which is the area where Manville WSC has demonstrated a need for service. The revised requested area is approximately 3,414.5 acres.

On April 29, 2021, the administrative law judge filed Order No. 8, which established a deadline of May 21, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to provide comments on the sufficiency of Manville WSC's amended application and amended maps and propose a procedural schedule. Therefore, this pleading is timely filed.

#### I. SUFFICIENCY OF REVISED MAPPING

Staff has reviewed the revised mapping information filed by Manville WSC, and as detailed in the attached memorandum of Jolie Mathis, Infrastructure Division, Staff recommends that the revised mapping be deemed sufficient.

#### II. PROPOSED PROCEDURAL SCHEDULE

Staff recommends that supplemental mapping be found sufficient; therefore, Staff proposes the following procedural schedule:

Event	Date
Deadline for Staff to provide final maps, certificates, and tariffs (if applicable) to Manville WSC for review and consent	June 25, 2021
Deadline for Manville WSC to file its signed consent form with the Commission	July 9, 2021
If no hearing is requested, deadline for Staff to file a final recommendation on the application	July 23, 2021
If no hearing is requested, deadline for parties to file joint proposed findings of fact and conclusions of law	August 6, 2021

Staff's procedural schedule does not include a deadline for re-noticing customers because Staff recommends that the original notice provided by Manville WSC is still sufficient. The revised requested area is wholly contained within the area described in the notice Manville WSC previously provided. Therefore, there are no additional landowners, neighboring utilities, or other affected entities who would need to receive notice of the requested CCN amendment.

#### **III. CONCLUSION**

For the reasons discussed above, Staff respectfully requests that Manville WSC's revised maps be found sufficient and that the proposed procedural schedule be adopted.

On May 18, 2020, Manville Water Supply Corporation (Manville WSC) filed with the Public Utility Commission of Texas (Commission) an application to amend its water Certificate of Convenience and Necessity (CCN) No. 11144 in Lee and Williamson Counties, Texas under Texas Water Code (TWC) §§ 13.242 to 13.250 and 16 Texas Administrative Code (TAC) §§ 24.225 to 24.237.

Staff from the Infrastructure Division has reviewed the revised mapping and digital data filed by Manville WSC on April 22, 2021. Manville reduced the size of the requested area from approximately 9,204.8 acres to 3,414.5 acres. Based on the mapping review by Tracy Montes, Infrastructure Division, Staff recommends that the revised mapping be deemed administratively complete.

Staff may determine that additional information is needed to make a final recommendation in this docket. If additional information is needed, Staff may send requests for information (RFI) to the Applicant. The Applicant will have 20 days from the receipt of the RFI to respond.
