

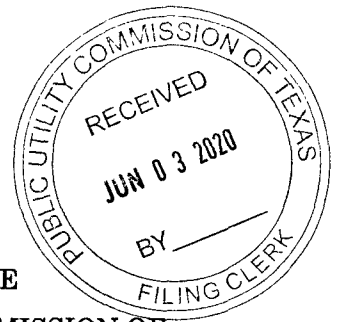

AMENDED AFFIDAVIT OF PAMELA COLLINS

BEFORE ME, the undersigned authority, on this day personally appeared Ms. Pamela Collins, who being by me first duly sworn, on oath, stated the following:

1. My name is Pamela Collins. I am a paralegal at the law firm Jackson Walker, L.L.P., who represents Texas-New Mexico Power Company ("TNMP") in the above referenced matter. I am authorized to make this affidavit and I have personal knowledge of all facts stated herein.
2. On May 29, 2020, TNMP filed with the Public Utility Commission of Texas ("PUC") an Application for Approval to Adjust the Energy Efficiency Cost Recovery Factor ("EECRF"). At the time of filing my original Affidavit on June 1, 2020, the EECRF proceeding had not yet been assigned a Docket No. On June 2, 2020, the PUC assigned the EECRF proceeding Docket No. 50894.
3. On June 1, 2020, pursuant to 16 TAC § 25.182(d)(13), a copy of the Notice of Rate Change Request ("Notice", Attachment A to the EECRF) was served via electronic mail¹, facsimile transmission, and/or U.S.P.S. certified mail on each of the parties participating in TNMP's most recent EECRF, Docket 49586, all REPs authorized to provide service in TNMP's service area at the time the EECRF application was filed, all parties in TNMP's most recently completed base-rate case, Docket 48401, and on the Texas Department of Housing & Community Affairs.²
4. On June 2, 2020 the PUC assigned this proceeding Docket No. 50894. A copy of the Notice of EECRF was re-served via electronic mail and/or U.S.P.S. certified mail on each of the parties participating in TNMP's most recent EECRF, Docket 49586, all REPs authorized to provide service in TNMP's service area at the time the EECRF application was filed, all parties in TNMP's most recently completed base-rate case,

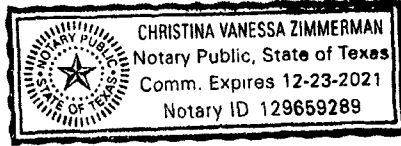
