UTILITY SERVICE AREA BOUNDARY

IN HARRIS COUNTY

Aldine Forest (public water system number 1010410; wastewater system permit number 11739001) Is located approximately 8.6 miles southwest of downtown Humble and is generally bounded on the north by a line approximately 1,200 feet north of and parallel to Lauder Road; on the east by Chrisman Road; on the south by Lauder Road; and on the west by Reeveston Road. The Aldine Forest service area includes approximately 16.1 acres, 48 current water connections, and 46 current sewer connections.

Mading Lane (public water system number 1010517) is located approximately 10.8 miles southwest of downtown Humble and is generally bounded on the north by Blue Bell Road; on the east by Airline Drive; on the south by Shane Street; and on the west by North Freeway (IH-45). The Mading Lane area includes approximately 32.1 acres and 113 current water connections.

North Belt Forest (public water system number 1011999; wastewater system permit number 12571001) Is located approximately 3.2 miles south of downtown Humble and is generally bounded on the north by Lexus Drive; on the east by a line 2,100 feet east of and parallel to Wilson Road; on the south by Loggia Lane; and on the west by Mesa Drive. The North Belt Forest area includes approximately 205 acres and 467 current water and sewer connections.

Parkland Estates (public water system number 1010192; wastewater system permit number 11158001) Is located approximately 5.4 miles southwest of downtown Humble and is generally bounded on the north by Aldine Bender Road; on the east by Rawlings Street, on the south by Nueces Park Drive; and on the west by Old Humble Road. The Parkland Estates area includes approximately 19.6 acres, 86 current water connections, and 69 current sewer connections.

West Montgomery (public water system number 1010670; wastewater system permit number 11005001) is located approximately 13.6 miles southwest of downtown Humble and is generally bounded on the north by West Mount Houston Road; on the east by Cora Street; on the south by Vesta Drive; and on the west by Streamside Drive. The West Montgomery area includes approximately 218.2 acres, 356 current water connections, and 351 current sewer connections.

Western Homes (public water system number 1010028; wastewater system permit number 10436001) Is located approximately 8.7 miles southwest of downtown Humble and is generally bounded on the north by Connorvale Road; on the east by Aldine Westfield Road; on the south by Isom Street; and on the west by Chrisman Road. The Western Homes water service area includes approximately 63 acres and 285 current water connections. The Western Homes sewer service area includes approximately 68 acres and 280 current sewer connections.

Whisper Meadows (public water system number 1011708; wastewater system permit number 12730001) is located approximately 4.6 miles southeast of downtown Tomball and is generally bounded on the north by the intersection of Huffsmith Kohrville Road and Wind Pine Lane; on the east by Huffsmith Kohrville Road; on the south by Solomon Road; and on the west by Coons Road. The Whisper Meadows area includes approximately 16.4 acres, 61 current water connections, and 60 current sewer connections.






