COMMISSION STAFF'S RESPONSE TO ORDER NO. 3

COMES NOW the Staff (Staff) of the Public Utility Commission of Texas (Commission), representing the public interest, and files this Response to Order No. 3. In support, Staff shows the following:

I. BACKGROUND

On June 3, 2020, Sharwat Quazi (Quazi) filed a complaint against Chelford City Municipal Utility District (Chelford City MUD) alleging that Chelford City MUD improperly disconnected Quazi's water service without notice.

On December 3, 2020, the administrative law judge (ALJ) filed Order No. 3, which established a deadline of January 8, 2021 for Staff to file a statement addressing: (1) whether Chelford City MUD holds a certificate of convenience and necessity (CCN); (2) whether CCN/Regnum numbers P0510 and P0092 are in effect; (3) whether those numbers constitute CCNs; and (4) if those numbers do constitute CCNs, whether either includes the area where Mr. Quazi's land is located. Therefore, this pleading is timely filed.

II. STAFF'S RESPONSE

Staff reiterates the assertion made in its Statement of Position, filed on July 6, 2020, that Chelford City MUD does not hold a CCN. While the Commission's database does list P0510 and P0092 as CCN/Regnum numbers assigned to Chelford City MUD, those numbers are not CCN numbers. A CCN number begins with either a "1" or a "2." A registration that begins with a "P" is assigned to a retail public utility like Chelford City MUD to indicate that it is a political subdivision that does not hold a CCN.¹ Such a designation allows Staff to keep track of those entities that are providing water or sewer service but do not hold a CCN. Because registration

III. CONCLUSION

Staff respectfully reaffirms its recommendation that this docket be dismissed under 16 Texas Administrative Code § 22.181(d)(1) for lack of jurisdiction.
