SUPPLEMENTAL AGREED MOTION TO ADMIT EVIDENCE

On June 3, 2020, the City of Pflugerville (Pflugerville) filed an application to amend its water certificate of convenience and necessity (CCN) number 11303 to incorporate areas it currently serves, to decertify a portion of Manville Water Supply Corporation's (Manville WSC) water service area, and to add approximately 38 acres of uncertificated service area in Travis County. Pflugerville also seeks dual certification with Manville WSC for certificated service area. The requested service area consists of 2,829 acres. On August 31, 2020 and October 23, 2020, Pflugerville filed supplements to the docket.

On July 2, 2021 Staff of the Public Utility Commission of Texas (Staff) filed Commission Staff's Supplement to Proposed Notice of Approval.
