COMMISSION STAFF'S REQUEST FOR EXTENSION

On June 16, 2020, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) number 11612 and sewer CCN number 20952 in Harris County. The requested service area consists of 98 acres with no current customers. On July 6, 2020, August 13, 2020, August 17, 2020, September 16, 2020, October 29, 2020, November 24, 2020, and January 7, 2021, Quadvest filed supplements to its application.

On December 1, 2020, the administrative law judge (ALJ) filed Order No. 5, requiring Staff to file a final recommendation on the application on or before March 8, 2021. Therefore, this pleading is timely filed.

I. REQUEST FOR EXTENSION

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. On March 2, 2021, Staff filed Commission Staff's Second Request for Information to Quadvest, L.P. (Second RFI). Staff requires responses to its Second RFI to draft and file its final recommendation on the application. Therefore, Staff respectfully requests that the deadline to file its final recommendation be extended to April 15, 2021.

II. CONCLUSION
