The proposed rates will apply to service received after the effective date provided below, unless modified or suspended by the Commission. The main reason for the proposed rate change is to recover capital investments of over \$35.1 million Monarch has spent over the past four-and-a-half years to maintain and improve its systems in order to provide quality water and wastewater service to customers.
