Dear Public Utility Commission of Texas,

We believe the water is unsafe to consume and our family has chosen not to drink it. We purchase drinking water for us and our pets elsewhere.

The water is brownish yellow and has particles floating in it.

When we first moved to the area and smelt a strong chlorine odor which made our eyes water, we were informed by the water company that they put chlorine in the water after repairing a leak. We were told the odor should disappear in 24-48 hours which it did, but we have concerns about this addition to our water supply.

We use the water to shower, do laundry, wash dishes, water the lawn and wash vehicles. Laundered clothes have to be washed and rewashed for them to come clean and our washer contains rust stains along with the toilets, tubs, and sinks in our home.

The cost of water via Monarch is high already and we don't use it 100% of the time. Having to buy water outside of our home increases our water costs, so we strongly protest a rate increase.
