We are protesting the Monarch Utilities proposed water rate increase effective 19 August 2020.

The requested water rate increase is totally ridiculous. The rate increase document I received from Monarch is suppose to clearly define the increase is not clear what the rate increase really is. The document doesn't define what the actual percentage rate is. The proposed 3.92 % increase does not compute as shown on their documents. We are retired with no increase in our Social Security but Monarch or Southwest Water Company is a large Company that is in 6 states.

Monarch or Southwest Water Company or Ridgecrest (Grayson Co.) Water System has had substantial increases over the past 15 years. The quality of water is not up to EPA requirements. We receive notices every few months that it still does not meet EPA requirements.

Now they are going to start charging us the new <u>REQUESTED – NOT APPROVED</u> <u>RATE ON AUGUST 19 2020</u>. The document stated that big improvements (\$35.1 M) had been made to the water supplied me. That may be so. But every 3 to 6 months We receive a letter from Monarch advising that the water supplied does not meet requirements of the EPA.

Monarch is headquartered in California with operations in 6 states no doubt making very good profits. How many millions or billions of \$\$\$\$\$ are they presently making??? Please do not let them rape us again just because they are a big company. Put on Your Big Boy and Big Girl panties and tell them NO!

This should go before a Judge immediately and tell Monarch "NO"! Don't allow an increase.
