AGREED MOTION TO AMEND PROCEDURAL SCHEDULE

Monarch Utilities I L.P., ("Monarch"), the Staff of the Public Utility Commission of Texas ("Staff"), and Office of Public Utility Counsel ("OPUC"), Ms. Kathy Nielsen (collectively, "Movants")¹ file this Agreed Motion to Amend Procedural Schedule in this docket and in support respectfully show the following:

I. BACKGROUND

In State Office of Administrative Hearings ("SOAH") Order No. 2, issued October 2, 2020, the SOAH Administrative Law Judges ("ALJs") conditionally adopted a procedural schedule jointly proposed by Movants that included a Mandatory Settlement Conference conditionally set for October 21, 2020.² In SOAH Order No. 3, issued October 15, 2020, the SOAH ALJs unconditionally adopted the procedural schedule.³

II. MOTION TO AMEND PROCEDURAL SCHEDULE

The Movants have agreed that more time is needed for review of the relevant issues before a productive Mandatory Settlement Conference can reasonably be expected. Movants therefore propose that the ALJs amend the procedural schedule, and set the Mandatory Settlement Conference for November 5, 2020, at 3:15 p.m.
