



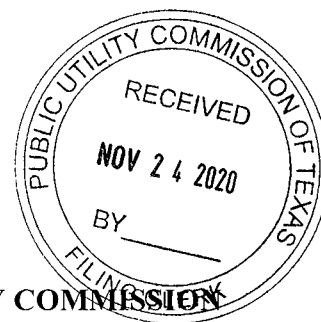

DEFINITIONS

STAFF 10-1 In Monarch's rate filing package (RFP), Schedule II-E-3, column (f), please provide the calculation for the total on Line 22, Taxable Component of Return of \$5,799,657. If the number does not total lines 3 minus line 6 minus line 8 minus line 9, please provide an explanation.

STAFF 10-2 If the response to RFI No. 1 indicates an error in the calculation of federal income tax, provide a corrected Schedule II-E-3 and any other schedules that needs to be corrected in Monarch's RFP due to the error.
