**AGREED REQUEST FOR EXTENSION**

Monarch Utilities I L.P. (Monarch) files this Agreed Request for Extension in response to the memorandum filed by Public Utility Commission of Texas' Commission Counsel on November 18, 2021. The memorandum requests responses to the issues it identifies by December 10, 2021. This request for extension is therefore timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 Tex. Admin. Code (TAC) § 22.4(b), Monarch requests that the Commission extend the deadline to file a response to the memorandum for 12 days, to December 22, 2021. Good cause exists for this extension as Monarch, Commission Staff, and the Office of Public Utility Counsel (OPUC) need additional time to fully review and investigate their records and all relevant facts in anticipation of filing a joint response to Commission Counsel's memorandum. This request is not intended for the purpose of unnecessary delay, and has not been caused by neglect, indifference, or lack of diligence. Monarch has conferred with Courtney Dean, counsel for Commission Staff, and Tucker Furlow, counsel for OPUC, who have both agreed to this request.

**II. CONCLUSION**

Monarch respectfully requests the issuance of an order granting this request and extending the deadline to file a response to Commission Counsel's memorandum to December 22, 2021.
