**AGREED REQUEST FOR EXTENSION**

On July 15, 2020, Monarch Utilities I, L.P. (Monarch) filed with the Public Utility Commission of Texas (Commission) an application to change the water and wastewater rates approved in its water and wastewater tariffs. On July 16, 2021, Monarch, Commission Staff, the Office of Public Utility Counsel, and Kathy Nielsen (collectively, the signatories) filed a stipulation and settlement agreement, along with agreed water and wastewater tariffs, in settlement of the matters at issue in this proceeding.

On February 23, 2022, a Final Order was issued, requiring Monarch's tap fees and damage-or-service-diversion fees to be set at actual cost, approving the water and wastewater tariffs except as modified by the Final Order, and requiring Commission Staff to file a clean copy of Monarch's tariffs, consistent with the Final Order, with Central Records within ten days of the Final Order. Therefore, this pleading is timely filed.

**I. JOINT REQUEST FOR EXTENSION**

Under 16 Texas Administrative Code (TAC) § 22.4(b), Commission Staff may request that the time allowed for filing any documents be extended for good cause. Commission Staff and Monarch are conferring on the language of the tariffs to be consistent with the modifications made by the Commission's Final Order. To allow time for Commission Staff to file a copy of the tariffs in accordance with the Commission's Final Order, Commission Staff and Monarch respectfully request that the deadline for Commission Staff to file a clean copy of the tariffs with Central Records be extended until March 18, 2022.

**II. CONCLUSION**

Commission Staff and Monarch respectfully request that the deadline for Commission Staff to file a clean copy of the tariffs with Central Records be extended until March 18, 2022.
