ANSWERS TO STAFF'S FIRST REQUESTS FOR INFORMATION

Staff 1-1 Please provide a list of any and all facility improvements and related costs for the Applicant to provide full service to the requested area, or the Applicant's capital improvement plan reflecting any and all facilities needed to serve the area requested.

RESPONSE:

1. Phase 1 Driftwood Golf and Ranch Club:
 - a. Interconnect with the WTCPUA 300 LF of 12-inch water line with meter and backflow preventer. The estimated cost is \$100,000.
 - b. 4,374 LF of 8-inch water line with valves, fitting, and appurtenances. The estimated cost is \$1,371,402.60 (see exhibit A).

2. Driftwood Development
 - a. 6,397 LF of 12-inch water line with valves, fitting, and appurtenances and 2,539 LF of 8-inch water line with valves, fitting, and appurtenances. The estimated cost is \$785,000.00 (see Exhibit B).

Staff 1-2 Please provide a description of the sources of funding for installation of any and all facilities required to serve the requested area.

RESPONSE:

The water system improvements will be funded by the developer, dedicated to the City of Drippings Springs, and the developer will later be reimbursed by the Driftwood Conservation District and the Driftwood MMD.
