## ORDER NO. 5 FINDING NOTICE SUFFICIENT AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the sufficiency of the notice provided by Nerro Supply, LLC and Undine Texas, LLC. On November 30, 2020, Commission Staff filed a recommendation regarding the notice provided.

Nerro and Undine filed proof of notice on November 18, 2020. The applicants filed the affidavit of Carey A. Thomas, senior vice president of Undine, attesting that notice was provided to current customers, neighboring systems, cities, and other affected parties on October 12, 2020. The applicants also filed tear sheets and a publisher's affidavit attesting that notice was published in the *Houston Business Journal*, a newspaper of general circulation in Chambers, Harris, and Liberty counties on October 16 and 23, 2020.

The administrative law judge finds the notice sufficient and establishes the following procedural schedule for continued processing:
