## <u>UNDINE TEXAS ENVIRONMENTAL, LLC'S</u> AUGUST 2021 STATUS REPORT AND REQUEST FOR EXTENSION

COMES NOW Undine Texas, LLC ("Undine") and files this August 2021 Status Report and Request for Extension in response to Order No. 9. Order No. 9 directed the Applicants to provide, on a monthly basis beginning May 12, 2021, an update on efforts to complete the transaction.

Undine hereby reports that Undine and Nerro Supply, LLC ("Nerro") have been working diligently to close the transaction following the April 12, 2021 approval to proceed with the transaction. The Parties have also been working on approval to close the transactions in the two related dockets of PUC Docket No.'s 50961 and 50962. The parties need close all three transactions simultaneously, if possible, and therefore request an extension of the deadline in this docket until November 8, 2021, to allow for the anticipated approval to close across the other two dockets.

Undine hereby requests, pursuant to 30 Tex. Admin. Code §22.5 or other applicable Commission procedural or substantive rule, an extension to November 8, 2021, to close the transaction. Undine represents that this request is not being made for the purpose of delay, but in order to properly conclude all of the actions prerequisite to closing the transaction. Undine believes the extension will serve the public interest and that it will not prejudice the rights of any

party and that good cause otherwise exists for this request. Undine is prepared to submit further information in support of this request as the request of the Administrative Law Judge.

The undersigned has consulted with Kourtnee Jinks, counsel for Commission Staff, who has stated Commission Staff has no objection to this request.
