REQUEST FOR EXTENSION

COMES NOW Undine Texas, LLC (“Undine”) and files this Request for Extension.

On August 12, 2021, the Administrative Law Judge (“ALJ”) granted Undine’s request for extension of time to complete the transaction. The ALJ set November 8, 2021 as the deadline for the transaction to be completed.


Undine hereby reports that despite the diligent efforts of Undine and Nerro Supply, LLC to close the transaction in advance of the November 8, 2021 deadline, the parties continue to work towards resolving all of the issues identified during the due diligence on the systems. Resolution of those issues is necessary in order for the parties to close the transaction.

Accordingly, Undine hereby requests, pursuant to 30 Tex. Admin. Code §22.5 or other applicable Commission procedural or substantive rule, a 60-day extension to the November 8, 2021 deadline, to January 7, 2022, to close the transaction. Undine represents that this request is not being made for the purpose of delay, but in order to properly conclude all of the actions prerequisite to closing the transaction. Undine believes the extension will serve the public interest and that it will not prejudice the rights of any party and that good cause otherwise exists for this request. Undine is prepared to submit further information in support of this request as the request of the Administrative Law Judge.

The undersigned has consulted with Merritt Lander, counsel for Commission Staff, who has stated Commission Staff has no objection to this request.
