ORDER NO. 12 RESCINDING ORDER NO. 8 AND ESTABLISHING PROCEDURAL SCHEDULE FOR MODIFIED APPLICATION

This Order addresses the December 1, 2021 request by Nerro Supply, LLC and Undine Texas, LLC to modify the existing application. Specifically, applicants state, since the filing of Order No. 9 on April 12, 2021, which approved the sale and transfer to proceed, applicants have been working diligently to close the transaction. However, based upon circumstances unable to be resolved, the applicants find it necessary to withdraw the Maple Leaf Mobile Home Subdivision system and the Oakland Village Mobile Home Community system from this application. For this reason, the applicants request approval to proceed with a modified application in which the Riverwood Estates system and the Woodland Acres Subdivision system will be the water systems sold and transferred in this case. Applicants represent that Commission Staff is not opposed to the request.

The administrative law judge grants applicants' request to modify the existing application and, in light of that modification, rescinds Order No. 9, approving the sale and transfer to proceed, and rescinds the finding of the application's administrative completeness in Order No. 3. Additional proof of notice, however, is not required, provided the proposed modification to the application only removes and does not add any land, rights, or facilities to the proposed transaction.

The following procedural schedule is established for continued processing of the modified application:

Deadline for parties to file a joint motion to admit evidence and proposed order approving sale and allowing the transaction to proceed	January 28, 2022
