<u>UNDINE TEXAS ENVIRONMENTAL, LLC'S</u> AUGUST 2021 STATUS REPORT AND REQUEST FOR EXTENSION

COMES NOW Undine Texas Environmental, LLC ("Undine") and files this August 2021 Status Report and Request for Extension in response to Order No. 8. Order No. 8 directed the Applicants to provide, on a monthly basis beginning March 12, 2021, an update on efforts to complete the transaction.

Undine hereby reports that despite the diligent efforts of Undine and Nerro Supply, LLC to close the transaction in advance of the August 10, 2021 deadline, the parties have found that circumstances relating to the resolution of certain title issues have delayed the closing of the transaction. The Parties also note a strong desire to conclude the transactions for the related assets in PUC Docket No.'s 50960 and 50962 at the same time as the transaction for the assets that are the subject of this docket.

Undine hereby requests, pursuant to 30 Tex. Admin. Code §22.5 or other applicable Commission procedural or substantive rule, a ninety-day extension to the August 10, 2021 deadline, to November 8, 2021, to close the transaction. Undine represents that this request is not being made for the purpose of delay, but in order to properly conclude all of the actions prerequisite to closing the transaction. Undine believes the extension will serve the public interest and that it will not prejudice the rights of any party and that good cause otherwise exists for this request. Undine is prepared to submit further information in support of this request as the request of the Administrative Law Judge.

The undersigned has consulted with Merritt Lander, counsel for Commission Staff, who has stated Commission Staff has no objection to this request.
