**APPLICANTS’ REQUEST FOR APPLICATION MODIFICATION AND SUBMITTAL
OF SUPPLEMENTAL MAPPING INFORMATION**

COME NOW Undine Texas Environmental, LLC (“Undine”) and Nerro Supply, LLC (“Nerro,” and collectively with Undine, the “Applicants”) and file this Request for Application Modification and Submittal of Supplemental Mapping Information.

On June 19, 2020, the Applicants filed the referenced application for the transfer of two water systems: Maple Leaf Gardens and Woodland Acres. On September 23, 2020, the Administrative Law Judge (“ALJ”) issued Order No. 3 finding the application administratively complete. On November 23, 2021, the ALJ issued Order No. 5 finding the notice sufficient and establishing a procedural schedule. On February 9, 2021, the ALJ issued Order No. 7 granting the joint motion to admit the evidence of the Applicants and Commission Staff filed on January 28, 2021. On February 11, 2021, the ALJ issued Order No. 8 approving the sale and transfer to proceed.

Since the February 11, 2021 Order, the Applicants have been working diligently to close the transaction. Based on circumstances the Applicants are unable to resolve, the Applicants find it necessary to withdraw one of the two systems from the transaction—the Maple Leaf Gardens system. The Applicants hereby request approval from the ALJ to proceed forward with the current application as modified to remove the Maple Leaf Gardens system from the application and leaving the Woodland Acres system as part of the application. The Applicants have agreed with

Commission Staff to work with Commission Staff to resubmit the Joint Motion to Admit Evidence and Proposed Order filed on January 28, 2021 to reflect the removal of the Maple Leaf Gardens system from the application. The Applicants do not consider that any additional procedural steps, including further notice, are necessary to accomplish this revision to the application, since the effect of the revision is to reduce the size of the impacted area and to reduce the number of customers affected by the application.

The Applicants are providing with this filing the new mapping data reflecting the single system that will remain in the application (maps are attached as Exhibit 1). The Applicants request that the ALJ establish a deadline for Commission Staff to file a supplemental recommendation on the sufficiency of the mapping data provided with this filing and a recommendation on the transaction as modified.

The Applicants have consulted with Commission Staff on this request, and they have stated they have no objection to the request.

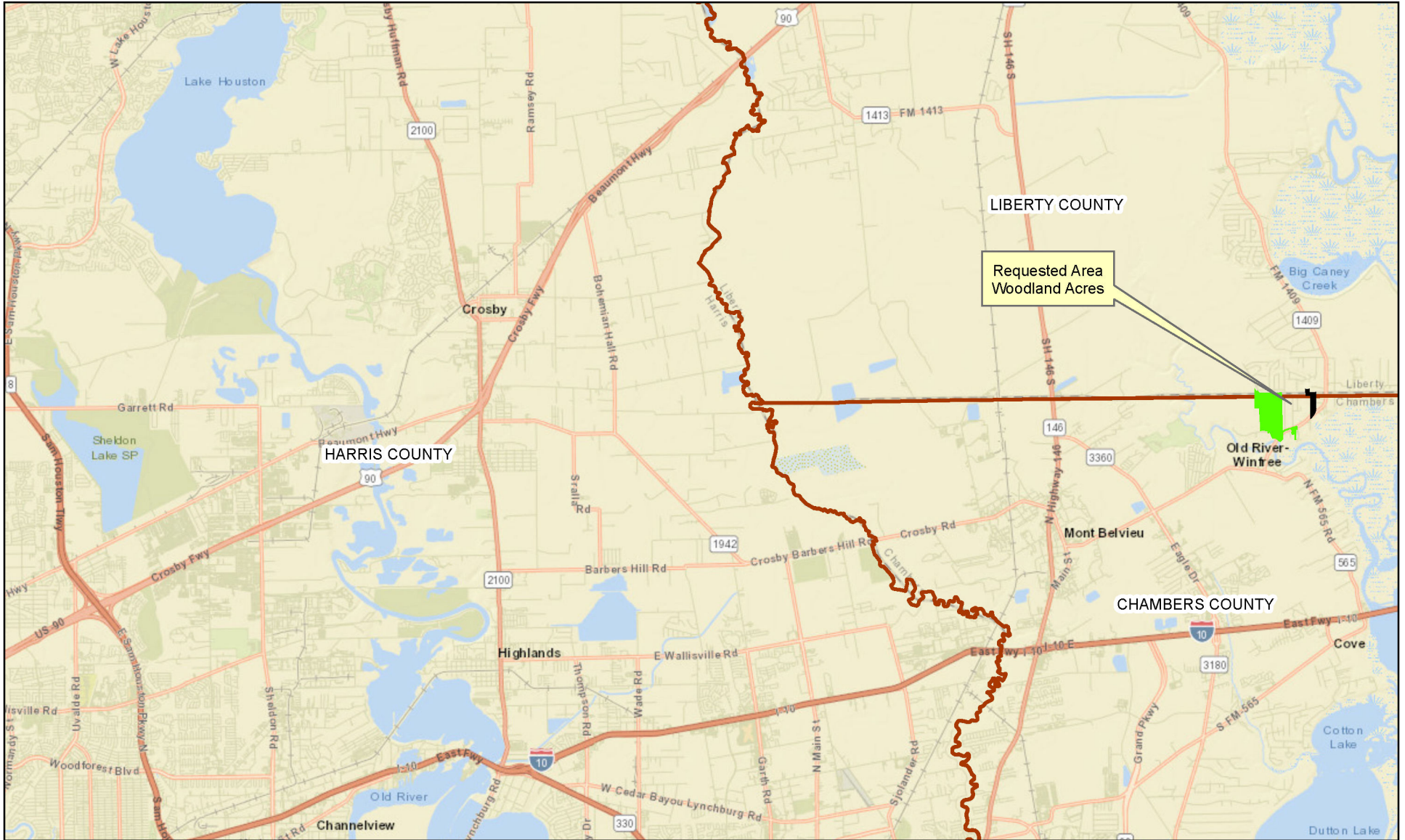

 in Chambers, Harris and Liberty Counties



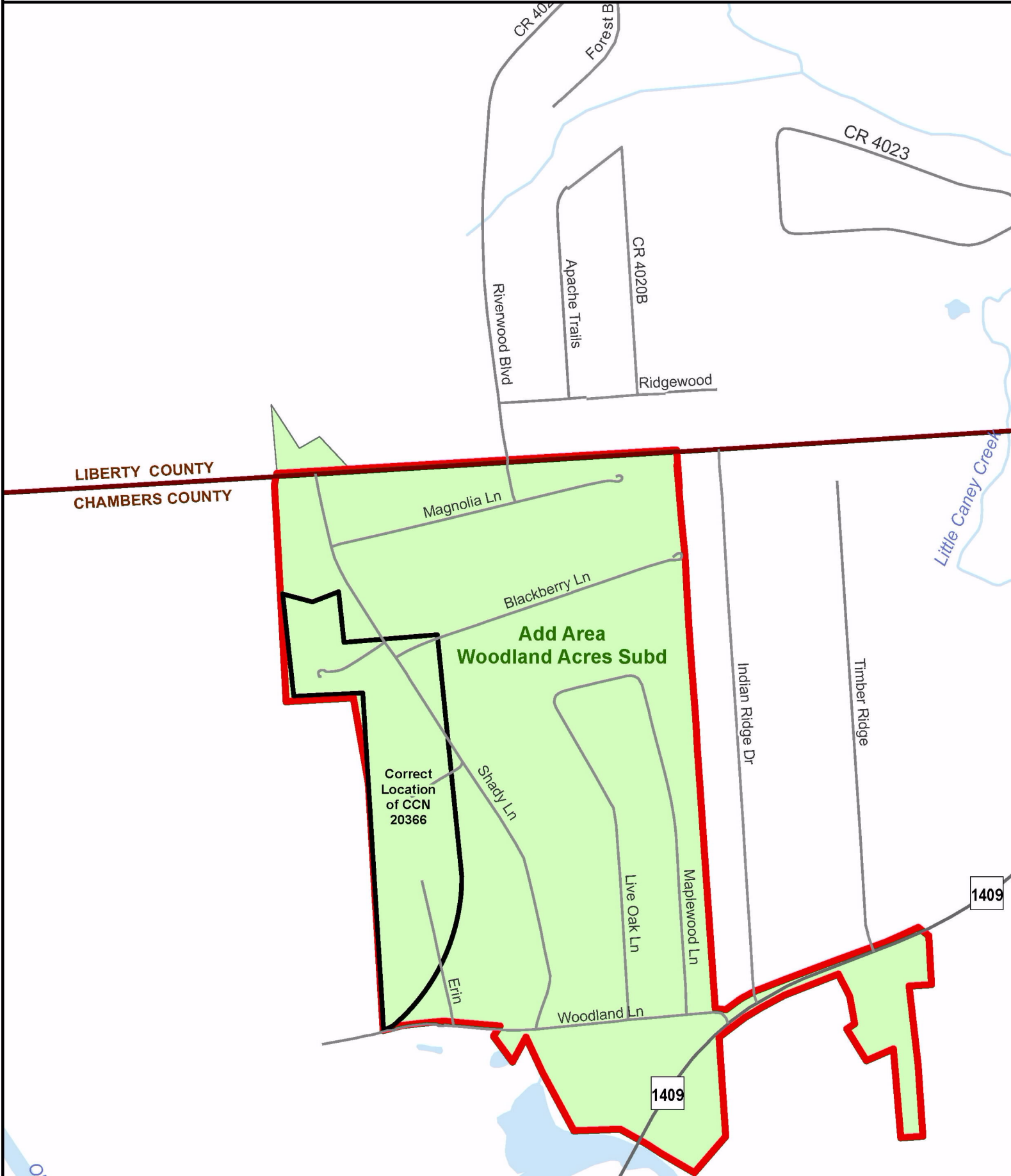
General Location - Harris, Chambers, and Liberty Counties
