ORDER NO. 5 GRANTING MOTION TO ABATE

This Order addresses the joint motion to abate filed by CSWR-Texas Utility Operating Company, LLC and Commission Staff on September 4, 2020. CSWR-Texas and Commission Staff request an abatement of this docket to allow the parties to focus on processing the other pending sale, transfer, or merger proceedings filed by CSWR-Texas. Specifically, the parties request abatement until "sufficient progress" has been made in Docket Nos. 50989, 151026, 251031, 351047, 451065, 551118, 651130, 7 and 51146. 8 The parties also propose to provide an update on the status of the abatement and a proposed schedule for this docket by October 15, 2020.
