



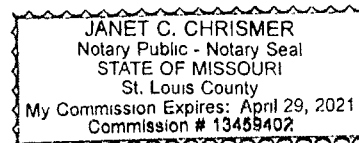

The sale is scheduled to take place if approved by the Commission (Texas Water Code § 13.301). The transaction and the transfer of the CCN includes the following subdivisions:
Oak Hills Ranch Estates, Oak Hills Ranchettes, Forest Oak Ranches & Ecletto Creek Ranchettes.

The requested area subject to this transaction is located approximately 8 miles east of downtown La Vernia, Texas, and is generally bounded on the north by a line approximately 1.5 miles north of Guadalupe/Wilson; on the east by SH 123; on the south by Longhorn Road; and on the west by a line approximately 2 miles west of SH 123. The total requested area for the water CCNs being transferred includes approximately 1,857 acres and 196 current customers. **See enclosed map showing the requested area.**

This transaction will not have an effect on the current customer's rates and services.

Persons who wish to intervene in the proceeding or comment upon action sought should contact the Public Utility Commission, P.O. Box 13326, Austin, Texas 78711-3326, or call the Public Utility Commission at (512) 936-7120 or (888) 782-8477. Hearing- and speech-impaired individuals with text telephones (TTY) may contact the commission at (512) 936-7136. The deadline for intervention in the proceeding is (30 days from the mailing or publication of notice, whichever occurs later, unless otherwise provided by the presiding officer). You must send a letter requesting intervention to the commission which is received by that date. The letter must include the person's name, address, email address and fax number if applicable.

If a valid public hearing is requested, the Commission will forward the application to the State Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an evidentiary hearing is held, SOAH will submit a recommendation to the Commission for final decision. An evidentiary hearing is a legal proceeding similar to a civil trial in state district court.

A landowner with a tract of land at least 25 acres or more, that is partially or wholly located within the requested area, may file a written request with the Commission to be excluded from the requested area (“opt out”) within (30) days from the date that notice was provided by the Utility. All opt out requests must include a large-scale map, a metes and bounds description of the landowner’s tract of land, landowner’s name, address, email address and fax number, if applicable.

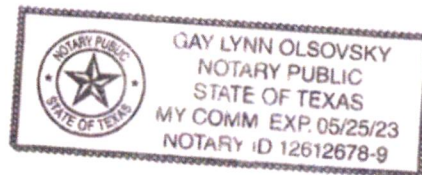

treating Humphrey as a lapdog. He told Carter he'd only become his running mate if given a meaningful role in the administration and an office in the White House. He composed a memo outlining his ideas that's still referenced today.

Vice presidents lost their invisibility. Biden talks about being in the room when key decisions are made, and when

copied in an internal correspondence.

It's difficult to imagine a repeat of 1945, when Harry Truman succeeded Roosevelt and didn't know that the United States had developed an atomic bomb.

Still, the limitations are visible when you listen to Bush. His vice president, Cheney, is widely considered the most powerful vice president, or close to it.

"I don't know what their definition of a powerful vice president is," Bush says in the film. "I think people have

got to recognize that the vice president is empowered by the president."

That's also stated explicitly by Pence, whose role in the Trump administration gets little examination in the film. Whatever the modern precedent, a president can easily render the vice president's role meaningless again.

In another month, the first woman, Kamala Harris, will join the vice president's club.

Considering its title, the film spends surprisingly little time talking about the most important part of the job

determine what."

Police sought the suspect for some time, Nichols said. After the earlier incident, they tracked him to the apartment and received assistance from the Guadalupe County SWAT for a stand-off situation.

According to Nichols, someone flagged down a police officer early Wednesday at Pic-N-Pack No. 3 on Stockdale Highway and said a man inside the restroom at the business was acting suspicious.

"The officer made contact with him and he stated he had just been robbed," Nichols said.

The man said he was in an altercation in the 5000 block of Violet, gave officers Moreno's name and police began watching the suspect's apartment at Oak Hollow.

At about 10:30 a.m. Wednesday, authorities learned Moreno had barricaded himself in his apartment, where he stayed until negotiators from the Seguin Police Department and Guadalupe County talked him into exiting the building.

Seguin Police and Guadalupe County SWAT members sur-

rounded and evacuated the building. It took officers about two hours to detain Moreno, as well as another person who was in the apartment with him.

Officers also reached out to the school district to ensure students stayed safe in case the suspect got past officers, Nichols said.

"We did communicate with the school district to let them know, in case he ran out the back window and we got into a foot pursuit with him," the chief said.

The district initiated lock out procedures on two nearby campuses — Barnes Middle School and Knoencke Elementary.

"At no time were our students or staff in any danger," Seguin ISD spokesman Sean Hoffmann said. "We did it in an overabundance of caution."

Police took Moreno to the Guadalupe County Jail. According to online records, he remained held there Friday under \$50,000 bond.

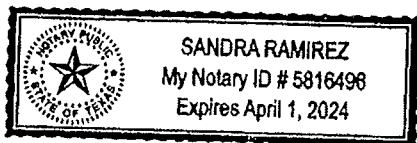
