COMMISSION STAFF’S REQUEST FOR EXTENSION

On July 1, 2020, Oak Hill Ranch Estates Water Company (Oak Hill) and CSWR-Texas Utility Operating Company, LLC (CSWR-Texas) (collectively, Applicants) filed an application for sale, transfer, or merger of facilities and certificate of convenience and necessity (CCN) rights in Guadalupe and Wilson Counties. The total requested area includes 196 connections and 1,857 acres comprised of existing service area that will be transferred, existing service area that will be decertified, and uncertificated area.

On June 8, 2021, the administrative law judge (ALJ) issued Order No. 12, requiring the parties to jointly file a supplemental motion to admit evidence, and proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs by August 6, 2021.

I. REQUEST FOR EXTENSION

Under 16 TAC § 22.4(b), Staff (Staff) of the Public Utility Commission of Texas (Commission) may request that the time allowed for filing any documents be extended for good cause. Neither Staff nor counsel for CSWR-Texas has succeeded in making contact with Mr. Billings regarding his consent to the final map and certificate. In order to allow Staff and CSWR-Texas more time to attempt to contact Mr. Billings and obtain his consent, Staff respectfully requests that the parties’ deadline to file joint proposed findings of fact and conclusions of law be extended to August 18, 2021. Counsel for CSWR-Texas is not opposed to this request for extension.

II. CONCLUSION

Staff respectfully requests the issuance of an order extending the parties' deadline to file a supplemental motion to admit evidence, and proposed notice of approval, including findings of fact, conclusions of law, and ordering paragraphs to August 18, 2021.
