**COMMISSION STAFF'S REQUEST FOR EXTENSION**

On July 6, 2020, Olan Johnson dba North University Estates Water Company (Olan Johnson) and Intermediary Solutions Holding, LLC (ISH) (collectively, Applicants) filed an application for approval of the sale, transfer, or merger of facilities and certificate rights in Lubbock County. ISH seeks approval to acquire facilities and to transfer Olan Johnson's water service area held under Certificate of Convenience and Necessity (CCN) No. 12179. The requested area includes approximately 106 acres and 192 connections.

On January 22, 2021, the administrative law judge (ALJ) issued Order No. 8, requiring Staff of the Public Utility Commission of Texas (Staff) to request a hearing or file a recommendation on approval of the sale on the CCN amendment by January 29, 2021. Therefore, this pleading is timely filed.

**I. REQUEST FOR EXTENSION**

Pursuant to 16 Texas Administrative Code (TAC) § 22.4(b), Staff may request that the time allowed for filing any documents be extended for good cause. Staff needs additional time to review the application. Staff respectfully requests the entry of an order extending the deadline for Staff to file a request for hearing or file a recommendation on approval of the sale on the CCN amendment by February 12, 2021.

**II. CONCLUSION**

Staff respectfully requests an order consistent with the foregoing request.
