**COMMISSION STAFF'S THIRD SUPPLEMENTAL RECOMMENDATION ON  
ADMINISTRATIVE COMPLETENESS AND PROPOSED PROCEDURAL SCHEDULE**

On May 20, 2020, Quadvest, L.P. (Quadvest) filed an application to amend its water certificate of convenience and necessity (CCN) number 11612 and sewer CCN number 20952 in Harris County. The requested service area consists of 26 acres and no current customers. Quadvest filed supplemental information on August 17 and September 15, 2020.

On February 2, 2021, the administrative law judge filed Order No. 6, setting a deadline of April 2, 2021 for the Staff of the Public Utility Commission of Texas (Staff) to file a supplemental recommendation on administrative completeness of the application and propose a procedural schedule. Therefore, this pleading is timely filed.<sup>1</sup>

**I. ADMINISTRATIVE COMPLETENESS**

To date, Quadvest has failed to file supplemental information to cure the deficiencies described in the memorandum of Jolie Mathis dated October 21, 2020. Staff therefore recommends that the application continue to be deemed administratively incomplete at this time. Because this application was filed in May of 2020, and Quadvest has not made a filing in this docket since December 2020, Staff reached out to Quadvest to discuss when it may be able to file supplemental information to cure the deficiencies identified in Ms. Mathis's memorandum. As of the time of filing, Staff has not received a response from Quadvest. Therefore, Staff recommends that Quadvest be given a deadline of April 12, 2021 to withdraw the application or make a filing stating when it will be able to provide information to cure the deficiencies in the application. Staff notes that Quadvest should not issue notice until the application is found sufficient.

## **II. COMMENTS ON PROCEDURAL SCHEDULE**

In accordance with Staff's deficiency recommendation, Staff does not propose a procedural schedule for further processing of this docket at this time. Staff intends to propose a procedural schedule alongside a subsequent recommendation for application sufficiency.

## **III. CONCLUSION**

For the reasons discussed above, Staff respectfully requests that the application be found administratively incomplete and that Quadvest be ordered to make a filing withdrawing the application or providing the date on which it will be able to provide supplemental information to cure the deficiencies in the application.
