#### ORDER NO. 2 PROVIDING CLARIFICATION ON DEADLINES AND AMENDING PROCEDURAL SCHEDULE

This Order addresses Commission Staff's July 31, 2020 motion for clarification of Order No. 1. In their motion Commission Staff requests clarification regarding Order No. 1 as to whether it is the intent to have Commission Staff address the four standard electric certificate of convenience and necessity (CCN) questions, and if necessary, that City of San Antonio, acting by and through the City Public Service Board (CPS Energy), be ordered to respond to the above issues by a specific date so that Commission Staff can formulate its recommendations or comments on CPS Energy's responses.

The administrative law judge (ALJ) clarifies that by August 5, 2020, CPS Energy is required to file responses to the four questions posed under the *Alternatives to Project* section of Order No. 1, not Commission Staff.<sup>1</sup>

The ALJ further amends the procedural schedule as follows:

Event	Deadline
Application filing date.	July 22, 2020
CPS Energy must provide Texas Parks and Wildlife Department a copy of the application.	July 29, 2020
CPS Energy must file responses to the four standard electric CCN questions regarding alternatives to the project.	August 5, 2020

CPS Energy must file proof of notice by mail.	August 11, 2020
CPS Energy must file proof of publication by filing a publisher's affidavit specifying each county where the newspaper is of general circulation.	August 17, 2020
Commission Staff must review the application and file recommendation or comments on administrative completeness.	August 20, 2020
Deadline for CPS Energy to file any reply to the recommendations or comments on these issues.	August 24, 2020
Administrative deadline of 35 days to file written order on administrative completeness of the application.	August 26, 2020
Deadline to intervene (45 days after filing).	September 8, 2020 <sup>2</sup>
