MOTION TO INTERVENE OF ANAQUA SPRINGS HOMEOWNERS' ASSOCIATION AND REQUEST FOR HEARING

Anaqua Springs Homeowners' Association ("Anaqua Springs HOA") submits this Motion to Intervene and Request for Hearing in the captioned proceeding pursuant to the Public Utility Regulatory Act ("PURA") and Public Utility Commission of Texas ("PUC" or "Commission") Procedural Rules 22.103 and 22.104. In support of its motion, Anaqua Springs HOA would show the following:

I. MOTION TO INTERVENE AND AUTHORIZED REPRESENTATIVES

On July 22, 2020, the City of San Antonio acting by and through the City Public Service Board ("CPS Energy") filed an application in this proceeding to amend its certificate of convenience and necessity ("CCN") in order to authorize construction of a proposed 138 kV transmission line in Bexar County, Texas. Anaqua Springs HOA owns real property that may be impacted by the proposed transmission routes. Thus, Anaqua Springs HOA is directly affected by the proposed line, has a justiciable interest in this proceeding, and has standing to intervene.
