Our one acre property and home are located on proposed Route 17 for electrical lines and poles serving the proposed new substation for CPS Energy. There are twentyone (21) properties in our subdivision (Serene & Scenic Hills) being <u>directly</u> affected in the same way. Route 17 begins at Toutant Beauregard and runs north along the entire western boundary of Serene and Scenic Hills that has been here since the 1960's, longer than most all other subdivisions that are now in the areas being considered for substations and electrical lines.

We strongly urge you to select an electrical route that will not <u>directly</u> affect so many properties and homes by encroaching on their back property lines with 70-130 foot metal poles holding electrical lines. Many homes will lose their beautiful view of the hill country because these poles and lines will obstruct their views, and home and property values will decrease as a result.

Substation 7 would be located on Toutant Beauregard directly across the street from Serene & Scenic Hills. The values of those home would also decrease with a view of a substation rather than a beautiful ranch, not to mention the addition of health and safety concerns.

We urge you to select substation sites and electrical line routes in locations that will not directly and negatively affect homes/properties.
