### SAVE HUNTRESS LANE AREA ASSOCIATION MOTION TO INTERVENE

Save Huntress Lane Area Association ("SHLAA" or "Movant"), hereby timely moves to intervene in the above-styled docket. The name, address, and telephone number of Movant's authorized representative is as shown below for the undersigned. Movant requests that all notices, correspondence, pleadings, briefs, and other documents be served upon the undersigned.

SHLAA is an unincorporated nonprofit association under Ch. 252 of the Tex. Bus. Org. Code. SHLAA is made up of over 30 individual landowners who reside in close vicinity to several of the proposed routes and/or have routes crossing their properties. Exhibit A hereto is a list of those individual landowners. In addition, the Canyons Property Owners Association is a member of SHLAA, and it represents the interests of over 700 landowners in the Canyons at Scenic Loop subdivision, whose properties are also in close vicinity to several of the proposed routes and/or have routes crossing their properties. Except for those members who intervene separately, the association is authorized to represent the interest of its members in this matter. Exhibit B hereto is a plat showing that association.

Because certain of the proposed transmission line routes will affect properties owned by these members of Movant, Movant has a direct, justiciable interest that may be adversely affected by this proceeding's outcome. Movant's interests are physically and legally distinct from any other party, and no other party to this proceeding can adequately represent Movant's interests. Movant accordingly requests that the motion to intervene be granted.
