CPS's current primary Route Z goes across or very close to three main subdivision entrances, it crosses Toutant Beauregard Rd several times in less than a mile, it is the most ill-favored, turbulent and hideous option, and it would put transmission lines close to schools.

Route Z affects the highest homeowner/property density. This directly affects all of Anaqua Springs Ranch, Sundance Ranch, Pecan Springs, and Scenic Hills at a projected value of \$1.5 Billion. Current research shows these values will be impacted between 18-40%, depending upon the distance of the transmission lines to the home.

Route Z proposes to put transmission lines behind an elementary school and a future middle school. There are a lot of medical concerns, both real and perceived regarding transmission lines and the development of leukemia and brain tumors in children.

Route Z also cuts across Toutant Beauregard Rd several times. Additionally, Route \bar{z} would cross the entrance into three large subdivision communities. Route Z is also the most visible, disruptive, and unsightly option out of any that have presented.

Originally presented at the open house in October 2019, Substation 1 connecting to Segment 12, presented none of these concerns. This would have affected ZERO m subdivisions, affected NO main access roads, affected ZERO schools, and would has \$12 Million vs \$1.5 Billion in valuations. Substation 1 connecting to Segment 12 w also be the shortest route as well as the least troublesome and disruptive by far. However, it has been eliminated as an option.

The current Substation 7 connecting to Segment 17 to Segment 28 meets all of the previous Substation 1 connecting to Segment 12 route provisions.

Building a substation on Toutant Beauregard Rd and setting up transmission tower which crisscross this busy road several times, are presumably the result of deals s by well-connected developers and landowners with CPS. This totally disregards th consequences upon individual homeowners.
