- Staff 1-1 Please reference pages 14 and 15 of the Application:
  - a. On page 14 of the Application, it is stated that the average length of circuits/feeders is approximately 12.8 miles. It is unclear if this average is for all distribution voltages or if this value is specific to the voltage class in the project area. Please provide the average length of the circuits/feeders at the distribution voltage that will be used in this project.
  - b. Please provide CPS's system wide reliability indices.
  - c. Please provide CPS's reliability indices for The La Sierra and Fair Oaks Ranch circuits/feeders
- Staff 1-2 Please provide the location of all existing schools in the project area and the distance each school is from the center line. If CPS is aware of any school that has been planned but not yet constructed in the project area (Planned Schools), please provide the location of any Planned Schools and the distance from the centerline of any of the proposed segments.
- Staff 1-3 Please reference Attachment 3 to the Application. Page 3 of Attachment 3 includes the substation cost estimates. The substation cost estimates appear to be the same in all categories except with regards to right-of way and land acquisition. Please provide a detailed explanation of any and all estimated cost differences between the different proposed substation sites.
