ANAQUA SPRINGS' OBJECTIONS AND MOTION TO STRIKE PORTIONS OF CPS' DIRECT TESTIMONY

Anaqua Springs Homeowners' Association ("Anaqua Springs HOA") submits these objections and motion to strike portions of Lisa Meaux's testimony. Anaqua Springs HOA objects to and requests that portions of Ms. Meaux's testimony and attachments be stricken on the grounds that such portions are not the best evidence under Tex. R. Evid. 1002. The parties agreed that objections to CPS Direct Testimony would be due on November 13, 2020. These objections are timely filed.

Anaqua Springs HOA objects and moves to strike the following testimony provided by Ms. Meaux, which can be found on page 10, lines 3-6 of her direct testimony:

In the letter, the Airforce and Army, who hold a third-party beneficiary interest in the property crossed by Segment 12, stated that they were opposed to the granting of an easement for the project across the Bandera Pass Easement.

This statement is Ms. Meaux's interpretation of what the letter states. The best evidence of what is contained in the letter is the letter itself, and nowhere in the letter does the word "opposed" occur. Furthermore, the easement document governs the rights of the Air Force and Army, not the letter to CPS. For these reasons, Anaqua Springs HOA objects to this limited portion of Ms. Meaux's testimony. However, Anaqua Springs HOA would have no objection to this portion of her testimony if she quoted from the letter (which is included as part of the Application) or from

the easement document (which does not appear to be included as part of the Application and is not yet in evidence).
