## **MOTION FOR EXTENSION OF TIME**

Anaqua Springs Homeowners' Association ("Anaqua Springs HOA") files this motion for extension of time to file its direct testimony and affidavits.

As a result of the winter storms, lawyers, staff, and witnesses for Anaqua Springs HOA have been without reliable power, water, and cell service since early Monday morning and have been dealing with temporarily relocating, managing frozen pipes, etc. While we have managed some workarounds, it has caused significant delays in finalizing testimony. Anaqua Springs HOA appreciates CPS's understanding of the situation and willingness to extend the filing deadline until Friday, February 19, 2021, without the need for a motion. In an abundance of caution, Anaqua Springs HOA is filing this motion because while Anaqua Springs HOA believes it may be able to file all testimony by Friday, it will depend on whether its attorneys are able to communicate with its witnesses. In any event, Anaqua Springs HOA will not be able to file affidavits for all witnesses until next week. The affidavits will not impact the substance of the testimony.

For these reasons, Anaqua Springs HOA respectfully requests that the Administrative Law Judges grant this request for an extension of time to file direct testimony and affidavits until such time as the Anaqua Springs HOA lawyers, witnesses, and clients are able to communicate.<sup>1</sup>
