Dear Judges Vandrovec and Shenoy:

In the Prehearing Conference in this docket on April 30, 2021, the Administrative Law Judges (ALJs) required CPS Energy to review certain parties on the service list that did not file direct testimony or a statement of position. Consistent with this requirement, the intervenors listed below have not filed either testimony or a statement of position as required in this case:
