ORDER NO. 5 FINDING APPLICATION ADMINISTRATIVELY COMPLETE, REQUIRING NOTICE, AND ESTABLISHING PROCEDURAL SCHEDULE

This Order addresses the proposed notice and administrative completeness of the July 8, 2020 application filed by Council Creek Village, Inc. dba Council Creek Village dba South Council Creek 2 and CSWR Texas Utility Operating Company, LLC for approval of the sale, transfer, or merger of facilities and certificates of convenience and necessity rights in Burnet County. The application was supplemented on July 14, August 7, and September 8, 2020. On September 4, 2020, a joint request for adoption of a revised procedural schedule was filed by Commission Staff and CSWR-Texas Utility Operating Company, LLC.

The administrative law judge (ALJ) finds the application administratively complete and directs the applicants to provide notice of the application and proof of notice in the manner described in Patricia Garcia's memorandum dated September 4, 2020, and attached to Commission Staff's supplemental recommendation on administrative completeness filed on September 4, 2020.

The ALJ grants the joint request filed on September 4, 2020, and adopts the following procedural schedule as proposed:

Deadline for applicants to provide notice	September 21, 2020

¹ The ALJ notes that on the same day Commission Staff filed its supplemental recommendation on administrative completeness, the parties filed a *Joint Response to Order Directing Administrative Processing and Proposed Procedural Schedule in Docket Nos.* 50276,50311,50989, 51003, 51026, 51031, 51036, 51047, 51065, 51089, 51118, 51126, 51130, 51146 and 51222, in which the parties filed an agreed upon procedural schedule. The ALJ is using the agreed upon dates.
