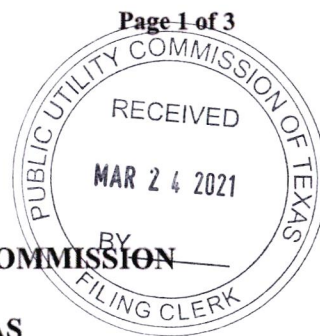

**UNOPPOSED EXTENSION FOR RESPONSE TO REQUEST FOR INFORMATION  
 AND REQUEST FOR EXTENSION OF TIME**

COMES NOW Rockett Special Utility District ("Rockett") and files this Unopposed Extension for Rockett's Response to the Request for Information and Joint Request for Extension of Time and would show the following:

Order No. 6 issued in this proceeding provided a procedural schedule, including deadlines for the filing of appraiser reports in the event expedited release was granted.<sup>1</sup> The Order issued on January 29, 2021 granted expedited release and required commencement of the schedule adopted in Order No. 6.<sup>2</sup> Rockett and FCS Lancaster, Ltd. ("Petitioner") did not select an agreed-upon appraiser within 10 days following the Commission's approval of the expedited release, and Rockett timely filed its Notice of Non-Agreement on Appraiser on February 9, 2021, according to the procedural schedule. On March 8, 2021, Petitioner filed its First Request for Information to Rockett.

Rockett has conferred with Petitioner and Staff of the Public Utility Commission ("Staff"), and the parties are unopposed for a one-week extension of time for Rockett to provide responses to Petitioner's First Request for Information, pursuant to 16 Texas Administrative Code § 22.144(k). Further, Rockett has conferred with Petitioner and Staff, and the parties are in agreement also for a one-week extension of time for the remaining deadlines provided in the procedural schedule of Order No. 6.


WHEREFORE, PREMISES CONSIDERED, Rockett requests a one-week extension to file its Response to Petitioner's First Request for Information on or before April 5, 2021, and a one-week extension for the remaining deadlines provided in Order No. 6.


