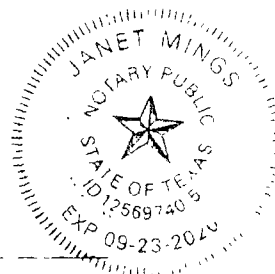

The requested area subject to this transaction is located approximately 15 miles north of downtown
Mineral Wells, Texas, and is generally bounded on the north by North Loop Road; on the east by
500 feet of intersection of FM 2210 and South Stadium Street; on the south by Back Cemetery
Road; and on the west by Price Lane. The total requested area for the water or sewer CCN(s)
being transferred includes approximately 163 acres and 129 current customers. **See enclosed map
showing the requested area.**

This transaction will not have an effect on the current customer's rates and services.

the person's name, address, email address and fax number if applicable.*

If a valid public hearing is requested, the Commission will forward the application to the State
Office of Administrative Hearings (SOAH) for a hearing. If no settlement is reached and an

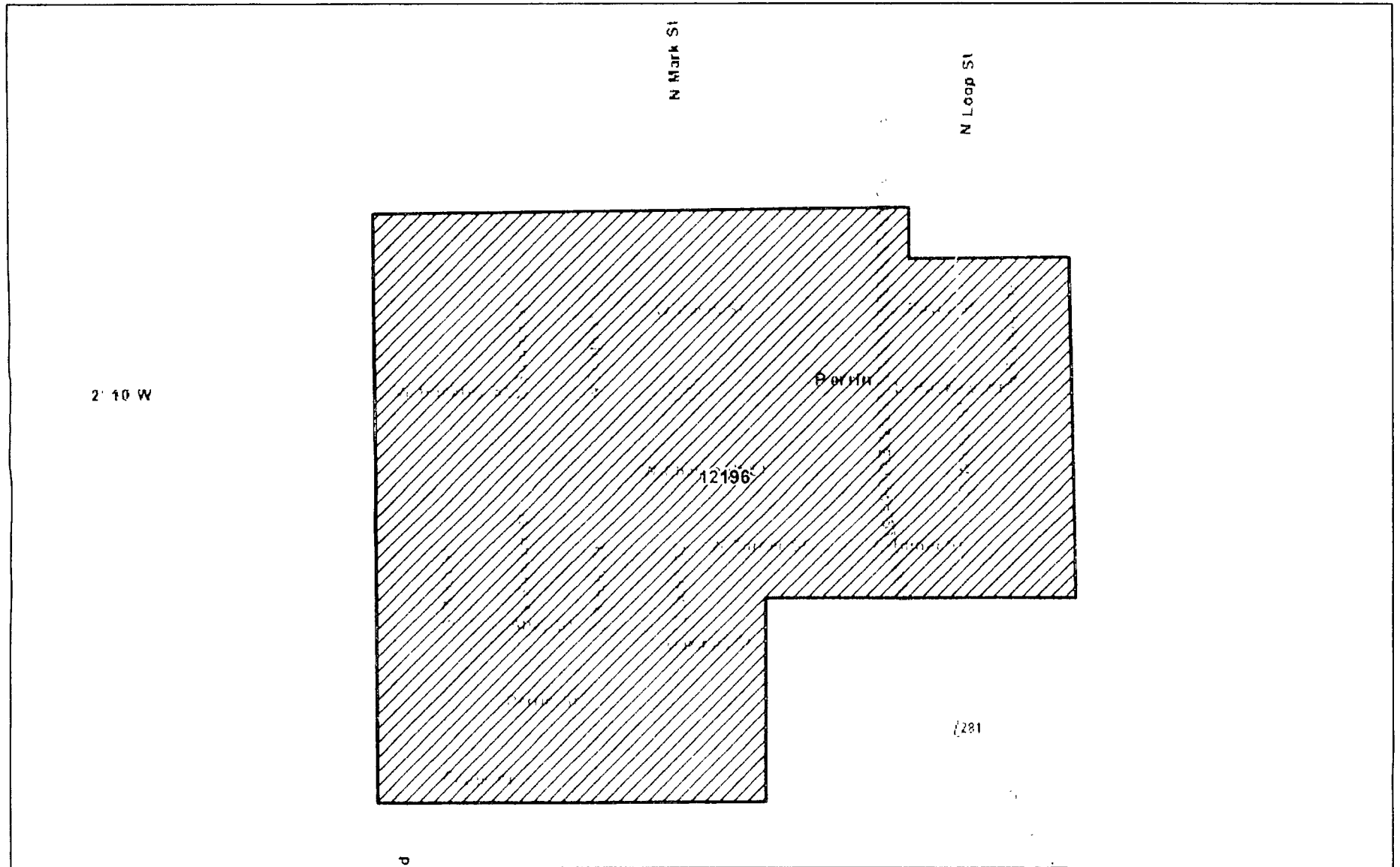

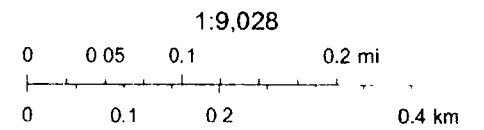
