

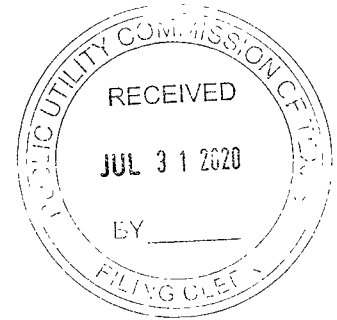

**AMERICUS HOLDINGS, LTD.'S  
FIRST SUPPLEMENT TO PETITION**

COMES NOW, Americus Holdings, Ltd. ("**Petitioner**"), by and through its undersigned attorneys of record, and hereby files this First Supplement to Petition. In support thereof, Petitioner would respectfully show as follows:

**I. BACKGROUND**

On July 20, 2020, Petitioner filed its Petition to Amend Gulf Coast Waste Disposal Authority's ("**Gulf Coast**") Sewer Certificate of Convenience and Necessity ("**CCN**") in Chambers County by Streamlined Expedited Release Under Texas Water Code ("**TWC**") § 13.2541 and 16 Texas Administrative Code ("**TAC**") § 24.245(l) (the "**Petition**") with the Public Utility Commission of Texas (the "**Commission**"). On July 27, 2020, Commission Staff advised Petitioner that the digital mapping data submitted with the Petition failed to meet the mapping requirements prescribed by 16 TAC § 24.257. On July 30, 2020, Commission Staff directed Petitioner to supplement the Petition with revised digital mapping data.

## **II. SUPPLEMENT**

Petitioner hereby supplements its Petition with the CD-ROM attached hereto and incorporated herein for all purposes as **Exhibit A**, which contains revised digital mapping data in a shapefile format, provided as a single, continuous polygon record, and georeferenced in NAD83 Texas Statewide Mapping System.

## **III. CONCLUSION**

For these reasons, Americus Holdings, Ltd. respectfully requests that the Commission grant its Petition, as supplemented hereby, and all other and further relief to which it may be entitled.
