DEFINITIONS

- 1) "Company" or "you" refers to Gulf Coast Waste Disposal Authority and any person acting or purporting to act on its behalf, including without limitation, attorneys, agents, advisors, investigators, representatives, employees or other persons.

- 6) If any document is withheld under any claim of privilege, please furnish a list identifying each document for which a privilege is claimed, together with the following information: date, sender, recipients or copies, subject matter of the document, and the basis upon which such privilege is claimed.

- Staff 1-3 Please provide any other documents that show evidence of sewer service from Gulf Coast Waste Disposal Authority to the Petitioner's tract of land.
- Staff 1-4 Identify the time period(s) during which the Petitioner's tract of land received sewer service.
