Pursuant to Texas Water Code § 13.257(r) and (s), CSWR-Texas Utility Operating Company, LLC (CSWR Texas), holder of water Certificate of Convenience and Necessity No. 13290 and holder of sewer Certificate of Convenience and Necessity No. 21120, hereby files this Boundary Description for the CSWR Texas water and sewer system, which is located in Hidalgo County, Texas.

In accordance with the aforementioned statute, CSWR Texas affirmatively states that its water and sewer service area included in the aforementioned CCN is as follows:

The requested area is located approximately one mile west of downtown Donna and is generally bounded on the north by a line roughly 150 feet north of and parallel to North Quiet Village Drive, on the east by a line roughly 100 feet east of and parallel to East Quiet Village Drive, on the south by a line roughly 150 feet south of and parallel to South Quiet Village Drive, and on the west by a line roughly 150 feet west of and parallel to West Quiet Village Drive.

The requested area, which is identical for water and sewer, includes approximately 18.5 acres and 165 current customers.

The water and sewer service areas are further depicted in the attached PUC certified maps.

The Boundary Description is being filed on behalf of and at the request and instruction of CSWR Texas based upon information and belief. CSWR Texas specifically authorizes the filing of this Boundary Description to comply with Texas Water Code § 13.257(r) and (s) and its associated rules and regulations.






