Mr. Rauschuber's background is in the field of Civil Engineering with specialties in the areas of water resources engineering/planning, including water and wastewater evaluations, regulatory permitting, environmental assessments, water/wastewater rates/appraisals, engineering economics/cost assessments, surface and ground water hydrology/development, municipal engineering/planning, facility planning/implementation, and regulatory reviews/permitting. 



IN CALENDAR YEARS 2018 AND 2019



NO WATER COMPLAINTS IN




CHART 3 NUMBER OF LOW PRESSURE OR




CHART 4

2018 AND 2019




CHART 5

CUSTOMER RANKED FROM LOWEST TO HIGHEST





CHART 6

RIO ANCHO CUSTOMERS







TWO AQUA FIELD REPRESENTATIVES

- 1. Installed recording water pressure gages: 103 Buffalo Trail and 408 Golden Eagle Trail
- 2. Rio Ancho Pump Station:
 - a. One 46,000-gallon ground storage bolted steel tank No construction activities have commenced for new GST/PT improvements
 - b. One 3,000-gallon pressure tank
 - c. Three booster pumps:
 - i. BP1 10 horsepower motor with pump
 - ii. BP2 10 horsepower motor with pump
 - iii. BP3 5 horsepower motor with pump
 - d. Aqua operator stated that he commenced Rio Ancho operations in August 2019. He opined that he discovered that the sequencing of the RA booster pumps was not properly set. Apparently prior to August, only one of the 10 horsepower booster pumps would operate in sequence with the 5-horsepower pump, while the second booster pump remained off-line. (During high water demands, this operation scenario would limit RA combined pumping capacity with only two pumps running.) Operator explained that he re-sequenced the three booster pumps so that all three pumps would run to meet high water demands.
- 3. Pump Station pressure was set at 64 psi booster pumps sequencing commences, as a function go GT water level) and at 76 psi booster pumps off.
- 4. 6-inch diameter suction line between GST and booster pumps
- 5. 6-inch diameter piping out of the pump station
- 6. Gas chlorination is being used.
- 7. 3,000-gallon PT floats on the system
- 8. Well No. 1 located at the RA Pump Station (see attached Goggle figure). This well works on a pressure switch located in the GST. Clocked flow on 12/10/19 was 47.3 gpm and 48.7 gpm
- 9. Well 2 (see attached Goggle figure) works on a pressure switch and turns on and off commensurate with Well 1 (i.e., both wells run and turn off at the same time. Clocked flow on 12/10/19 was 46 gpm and 49 gpm.
- 10. Well 3 (see attached Goggle figure) works on a timer. The well turns on a 2:00 a.m. each day and turns off at 6 a.m. each day, regardless of water demand or GST level. Clocked flow on 12/10/19 46.2 gpm and 47.7 gpm.



IN CALENDAR YEARS 2018 AND 2019



NO WATER COMPLAINTS IN



NO WATER COMPLAINTS IN




CHART 4

2018 AND 2019




CHART 5

CUSTOMER RANKED FROM LOWEST TO HIGHEST





CHART 6

RIO ANCHO CUSTOMERS





3	Q.	Does this include issues, concerns and problems with utility service providers?
4	A.	Yes.
5	Q.	When did you become aware of issues with reliability of service with Aqua Texas,
6		Inc., the water utility providing service to the Rio Ancho Subdivision?
7	A.	Shortly after I assumed the role as community manager for the Rio Ancho Homeowners
8		Association I learned that there were frequent instances of homeowner complaints of
9		extremely low water pressure and loss of service. These problems primarily occurred in
10		the spring, summer and early fall time period and were quite frequent.
11	Q.	What actions would you take on behalf of the homeowners association when these
12		problems arose?
13	A.	I would notify the operator of the utility Aqua Texas, Inc. of the issue, addresses affected
14		and the nature of the service problem. Homeowners were advised to make informal and
15		formal complaints with the Public Utility Commission in Texas or the Texas Commission
16		for Environmental Quality as customers of the utility.
17	Q.	Did these actions result in improvement in continuity of service to the residents of the
18		subdivision?
19	A.	No. The problems continued and persisted through last year.
20	Q.	What further action did the homeowners association take to address these issues?
21	A.	In November of 2019, the homeowners association engaged attorneys at McGinnis
22		Lochridge LLP in Austin and Don Rauschuber, a professional engineer, with extensive
23		experience in small utility operations to advise the homeowners association on causes and
24		solutions to the problems being experienced and remedies they might pursue.
